## Misuse of Drugs Act 1975

### Misuse of Drugs (Prohibition of Cannabis Utensils and Methamphetamine Utensils) Notice 2014

Pursuant to section 22(1A) of the Misuse of Drugs Act 1975, the Minister of Health gives the following notice.

#### Notice

**1. Title**—This notice is the Misuse of Drugs (Prohibition of Cannabis Utensils and Methamphetamine Utensils) Notice 2014.

**2. Commencement**—This notice comes into force on **12 May 2014**.

**3. Interpretation**—In this notice, unless the context otherwise requires—

**Act** means the Misuse of Drugs Act 1975.

**cannabis** means any of the following:

- A cannabis preparation as described in clause 1 of Part 1 of Schedule 2 of the Act;
- a cannabis fruit, cannabis plant, or cannabis seed as described in Part 1 of Schedule 3 of the Act.

**cannabis utensil** means any of the following utensils that may be used for administering cannabis, and that has 1 or more prohibited features:

- A bong;
- a hash pipe;
- a roach clip with a pincer or tweezer action.

**methamphetamine** means any of the following:

- The substance methamphetamine as described in clause 1 of Schedule 1 of the Act;
- the isomers of the substance mentioned in paragraph (a) whenever the existence of isomers of that kind is possible within the specific chemical designation;

- (c) the esters and ethers of the substance mentioned in paragraph (a) and the esters and ethers of the isomers mentioned in paragraph (b) whenever the existence of esters or ethers of that kind is possible;
- (d) the salts of the substance mentioned in paragraph (a) and the salts of the isomers, esters, and ethers mentioned in paragraph (b) or (c);
- (e) substances containing any proportion of a substance mentioned in paragraphs (a) to (d).

**methamphetamine utensil—**

- (a) means a pipe that has the following features:
  - (i) A bowl all of which or the base of which is made of glass, metal, ceramic, or another flameproof and heat-conducting material; and
  - (ii) a stem leading directly off the bowl and ending with a mouthpiece; and
  - (iii) no insertion (of gauze, wire mesh screen, or of another material that is not designed or intended to be burnt or dissolved) between the bowl and stem; and
  - (iv) a hole, either on the bowl or on the stem;
- (b) or any item that has been modified in such a way as to facilitate the use of methamphetamine; but
- (c) does not include a pipe manufactured for use as a pipe to smoke tobacco.

**prohibited feature means—**

- (a) in the case of a bong or a hash pipe, any of the following features:
  - (i) More than 2 holes;
  - (ii) more than 1 inhalation hose (breathing port);
  - (iii) provision for cooling smoke by drawing the smoke through water;
  - (iv) a metal or ceramic or glass bowl;
  - (v) an insertion placed in a bowl, which is an insertion that is a gauze, a wire mesh screen, or an insertion made of material that is not designed or intended to be burnt or dissolved in the bowl;
- (b) in the case of a roach clip with a pincer or tweezer action, a depiction of cannabis fruit, cannabis seed, or any part of the cannabis plant, or a depiction that could reasonably be taken to be a depiction of cannabis fruit, cannabis seed, or any part of the cannabis plant.

**prohibited goods power, function, or duty** means a power, function, or duty conferred or imposed by the Customs and Excise Act 1996 and that may be exercised or performed in respect of prohibited goods, for example—

- (a) The power under section 233(1)(c) of that Act to grant relief in respect of seized goods; and
- (b) the power under section 236(2) of that Act to order restoration of goods forfeited to the person from whom the goods were seized.

**supply**, in relation to utensils that are prohibited goods because of section 54(1)(a) and Schedule 1 of the Customs and Excise Act 1996, does not include the actual or purported exercise or performance, in respect of those utensils, of a prohibited goods power, function, or duty.

**4. Importation, supply, and offer for sale of cannabis utensils and identifiable components of cannabis utensils prohibited—**

No person may—

- (a) import a cannabis utensil or an identifiable component of a cannabis utensil; or
- (b) supply a cannabis utensil or an identifiable component of a cannabis utensil; or
- (c) offer for sale a cannabis utensil or an identifiable component of a cannabis utensil.

**5. Importation, supply, and offer for sale of methamphetamine utensils and identifiable components of methamphetamine utensils prohibited—**

No person may—

- (a) import a methamphetamine utensil or an identifiable component of a methamphetamine utensil; or
- (b) supply a methamphetamine utensil or an identifiable component of a methamphetamine utensil; or
- (c) offer for sale a methamphetamine utensil or an identifiable component of a methamphetamine utensil.

**6. Revocation—**The Misuse of Drugs (Prohibition of Cannabis Utensils and Methamphetamine Utensils) Notice 2003 (SR 2003/398)\* is revoked.

**3. Reasons for this amendment**—The reasons for amending the principal exemption are as follows:

(a) The Authority granted the principal exemption to AccuCal for the following reasons:

- (i) Granting the requested exemption met the requirements in section 11(2) of the Act for granting exemptions;
- (ii) there would be significant cost to replace the metering installations at the Ohaaki power station to comply with the obligation in clause 4(2)(a) of Schedule 10.7 of the Code;
- (iii) the derivation of submission information from the metering installations by subtraction is as accurate as it would be if it was derived using accurate metered data and was acceptable under the Code in the exact same configuration when the equipment was owned by the grid owner;
- (iv) the exemption from clause 4(2)(a) of Schedule 10.7 of the Code will allow AccuCal, as the metering equipment provider ("MEP"), to arrange certification of the existing metering installations at this installation control point ("ICP") even though the metering configuration currently uses subtraction to determine submission information; and
- (v) the requested exemption will have no impact on any other participant or service provider, and will not affect any other Code provision;

(b) although the Authority approved granting the principal exemption in respect of ICP No. 0000032431HR99C, due to an administrative error, the exemption was inadvertently granted in respect of the incorrect ICP;

(c) it is therefore necessary to amend the principal exemption to refer to the correct ICP number; and

(d) accordingly, the Authority is satisfied that:

- (i) for the reasons set out in the principal exemption, the amendment is necessary or desirable for the purpose of achieving the Authority's objective under section 15; and
- (ii) the benefit of the amendment outweighs any disadvantage resulting from any increased administration and compliance costs.

#### Health Practitioners Competence Assurance Act 2003

##### Notice of Scope of Practice and Prescribed Qualifications for the Practice of Anaesthetic Technology in New Zealand

Pursuant to sections 11 and 12 of the Health Practitioners Competence Assurance Act 2003, this notice replaces the previous notice (published in the *New Zealand Gazette*, 5 April 2012, No. 40, page 1201) issued by the Medical Sciences Council of New Zealand (“Council”).

This notice sets out the scope of practice and qualifications for the practice of anaesthetic technology in New Zealand as required by sections 11 and 12 of the Health Practitioners Competence Assurance Act 2003 (“Act”).

##### The Profession of Anaesthetic Technology

Anaesthetic technology is the provision of peri-operative technical management and patient care for supporting the provision of quality health care and safe anaesthetic services in New Zealand accredited health facilities.

Tasks included in this definition, but not limited to, are:

- anaesthetic related research and development;
- applied science and anaesthetic technology education;
- advanced patient monitoring;
- collection of samples for diagnostic investigation; and
- management.

##### Scope of Practice

The profession of anaesthetic technology contains one scope of practice of an anaesthetic technician.

Pursuant to section 11 of the Act, the Council specifies the anaesthetic technician scope of practice as:

An **anaesthetic technician** is a member of an anaesthetic care team, working collaboratively with other health professionals.

An **anaesthetic technician**:

- Utilises technical and clinical judgment to assess peri-operative requirements and provide patient care and assistance during all aspects of anaesthetic administration and during anaesthetic related procedures.
- Cannot prescribe and/or administer agents used for general anaesthesia and/or sedation independently. Administration of anaesthetic agents can only occur in an assisting role under the direction of a medical anaesthetist<sup>1</sup> or intensive care specialist.
- Provides support to the medical anaesthetist or intensive care specialist and collaborates and works alongside other health professionals during peri-operative, interventional and investigative procedures.
- Provides anaesthetic assistance in operating departments, radiology and MRI units, intensive care, obstetric and emergency departments and any other area where anaesthesia is administered.
- Provides support for the safe transportation of patients, both within the hospital environment and/or between hospitals or surgical healthcare facilities.
- Works as a team member alongside other health workers.<sup>2</sup>
- Provides physical and emotional support to the patient to enhance the safe outcome of anaesthetic procedures.
- Anticipates and prepares the equipment, monitoring and other requirements specific to each anaesthetic procedure.

The Council’s Competencies for Anaesthetic Technicians describe the skills and activities of an anaesthetic technician.

**Prescribed Qualifications**

Pursuant to section 12 of the Act, the following qualifications are prescribed for registration as an anaesthetic technician:

1. A tertiary qualification in anaesthetic technology from a New Zealand university combined with relevant and specialised anaesthetic technology experience and successful completion of an anaesthetic technician examination, all of which are accredited and/or approved by the Council.
2. A course of training and/or examinations combined with relevant and specialised anaesthetic technology experience that, in the opinion of the Council, is substantially equivalent to the course of the New Zealand prescribed qualification.
3. Certification in anaesthetic technology by an authority outside New Zealand, combined with relevant and specialised anaesthetic technology experience and/or the successful completion of an anaesthetic technician examination, all of which are approved and/or accredited by the Council and that, in the opinion of the Council, is sufficient for registration as an anaesthetic technician.
4. New Zealand registered and enrolled nurses who have at least five years' post-nursing-qualification specialised anaesthetic technology experience in a New Zealand health facility may apply for registration as an anaesthetic technician. The nurse may be required to undergo a work-based assessment as approved by the Council.
