Ministerial Statement to Accompany Direction to the Registrar of the New Zealand Emission Unit Register

In making the above direction to the Registrar, I have consulted with the Minister of Finance and I have had regard to the following matters specified in section 68 of the Climate Change Response Act 2002:

Section 68(2)(b)(i)

The number of units that New Zealand has received, or that the Minister expects New Zealand to receive, under any international agreement

New Zealand has received 309,564,733 Assigned Amount Units (AAUs) under the Kyoto Protocol. New Zealand has elected to receive removal units for net increases in forest sinks (RMUs) at the end of commitment period one (CP1). It is estimated New Zealand will receive 79.9 million RMUs.

Section 68(2)(b)(ii)

New Zealand's international obligations, including any obligation to retire units equal to the number of tonnes of emissions that are emitted in New Zealand

Under the United Nations Framework Convention on Climate Change, New Zealand has a commitment to adopt policies and measures to mitigate climate change.

New Zealand also has obligations under the Convention's Kyoto Protocol, whereby it must retire sufficient Kyoto units to cover its total emissions during CP1 or face non-compliance consequences. The most recent Net Position Report (published in April 2010) projected New Zealand's total emissions of greenhouse gases for the first commitment period to be 370.9 million tonnes of CO₂-e. New Zealand has received 309,564,733 AAUs and expects to receive 79.9 million RMUs.

In other words, New Zealand is currently projected to have more units than emissions. The current projected surplus is 11.4 Mt CO₂-e although this will be updated in May 2011. A provision for the Kyoto liability is reported in the Financial Statements of the Crown.

Section 68(2)(b)(iii)

The proper functioning of the greenhouse gas emissions trading scheme established under this Act

The proper functioning of the NZ ETS requires the issuance of sufficient NZUs to meet entitlements of post-1989 forestry participants; any entitlements under an allocation plan; and any auctions of NZUs

the Crown undertakes.

Officials estimate that in CP1, 60 million NZUs will be allocated to post-1989 forest land owners (based on the mid range projection of 67 percent uptake); 17 million NZUs will be issued to pre-1990 forest land owners; 11 million NZUs will be issued to emissions intensive, trade exposed industry; 700,000 NZUs will be allocated to the fishing sector; 4 million will be issued to those carrying out removal activities, or other non-forestry related activities; and 1 million units will be granted to parties to meet the Crown's obligations under the two Negotiated Greenhouse Gas Agreements.

Officials will monitor the balance of units closely to ensure a further issuance, or cancellation of units in 2012 can occur to maintain the proper functioning of the NZ ETS.

Section 68(2)(b)(iv)

Any other matters that the Minister considers relevant

Under section 86F of the Climate Change Response Act, by the end of the true-up period under the Kyoto Protocol (which will be in 2015 for CP1), the Crown holds a number of Kyoto units equal to the number of NZUs issued into a Crown holding account during CP1, subject to specified exemptions. The projected net flow of units to the Government under the scheme is such that obligation to back issued NZUs with Kyoto units means the Crown will have a deficit of approximately 30 million units.

In addition, careful monitoring of the Commitment Period Reserve between now and 2012, and the Crown's position in 2012 to ensure that the Government's obligations are met at least cost, is required.

In May 2008, the Commerce Commission set thresholds for the declaration of control in relation to Transpower New Zealand Limited under Part 4A of the Commerce Act 1986 ("the Act") and published those thresholds in a Supplement to the New Zealand Gazette, 27 June 2008, No. 106, page 2793, as the Commerce Act (Transpower Thresholds) Notice 2008 (the "principal notice").

Further detail regarding the thresholds can be found in a Decision Paper, Decision and Reasons for not Declaring Control of Transpower New Zealand Limited & Decision to Reset Transpower's Thresholds, published by the Commerce Commission on 13 May 2008.

The majority of the provisions of Part 4A of the Act were repealed by the Commerce Amendment Act 2008 on 14 October 2008 and replaced with a new Part 4. However, under Part 4, Transpower continues to be subject to its administrative settlement until its expiry date of 30 June 2011 (section 54M). This notice is, therefore, issued under Part 4 of the Act.

The amendment now made to the principal notice by the amendment notice set out above is to set a transmission (non-Part F capex) threshold for the assessment period ending 30 June 2011, as required under Schedule 2, Part 2, clause (j). au4401

Telecommunications Act 2001

Notification of Clarification of the Standard Terms Determinations on Telecom's Unbundled Bitstream Access Service

On 12 December 2007, the Commerce Commission ("Commission") made a standard terms determination, under section 30M of the Telecommunications Act 2001 ("the Act"), in respect of the designated access service of Telecom's Unbundled Bitstream Access ("UBA") Service ("Decision 611") which has been amended by way of clarification under section 58 of the Act on a number of occasions.

- clauses 4.1, 4.2 and 4B of the UBA Price List (Schedule 2 to the UBA General Terms) to ensure that the wholesale price calculations for the UBA Service (which are conducted on a regular basis) are not affected by retail broadband plans that are supplied by Telecom using new UBA Variants;
- clause 5.1 of the UBA Price List to ensure consistency with other amendments made and to provide clarity as to the plans that may be considered as part of any quarterly or service adjustment calculation.

Electricity Easement

Unless otherwise provided below, the rights and powers implied in specific classes of easements are those prescribed by the Land Transfer Regulations 2002.

 - (iii) breaches any bylaw or Regulation or other statutory provision relating to the easement facility.

- (b) On completion of any work to the easement facility, the surface of the servient land will be restored as nearly as possible to its former condition.
- (c) The grantee shall have exclusive rights to the easement facility in relation to the easement right to convey electricity and to install and convey telecommunications, network signals and multimedia data.
- (d) The grantor grants to the grantee and all persons authorised by the grantee with or without materials, plant and other apparatus and vehicles, to enter and cross the servient land as necessary at all times of the day and night via any practical route of access to the stipulated area subject to the grantee repairing and reinstating any damage to the servient land or its appurtenances caused by such access and crossing.
- (e) The grantor must not, without the written consent of the grantee which consent may be withheld in the grantee's absolute discretion:
 - (i) build or allow to be built or grow on the servient land any structure or plant which will interfere with the grantee's permitted use of the stipulated area;
 - (ii) alter existing ground levels on the servient land on or adjacent to the stipulated area;
 - (iii) prevent any of the grantee's permitted uses being conducted in a normal manner.
- (f) If:
 - (i) the stipulated area is damaged or destroyed or if there is interruption to access to the stipulated area so as to render the stipulated area or any part of the stipulated area wholly or substantially unfit for the occupation or use of the grantee or inaccessible by any means of access; or
 - (ii) the grantee commits a material breach of any of its obligations and has not remedied that breach after having been given written notice of that breach and after the lapse of a reasonable time after that notice having regard to the nature of that breach; or
 - (iii) any application for a required or further consent or permit from any government agency or other competent authorities for the installation and use of the stipulated area is declined or granted subject to conditions which are unacceptable to the grantee and the grantee determines in its sole discretion not to appeal such decline or unacceptable decision or take any further action in respect of the same, or if the grantee is unsuccessful in any appeal or further action which it does take; or
 - (iv) the stipulated area is rendered unfit for the grantee's use; or
 - (v) some alteration in the grantee's operational requirements or some change in government legislation or by-laws or planning requirements renders the grantee's use of the stipulated area obsolete or unnecessary, then the easement may be terminated immediately by the grantee by written notice to the grantor.
