Rules for Student Enrolment Records

Under section 77A(3) of the Education Act 1989, I make the following rules.

Definitions

In these rules, unless the context otherwise requires:

- "authorised user" means a person who has completed a user authorisation form and who has been provided with access to ENROL by the Ministry.
- "ENROL" means the enrolment management system established by the Ministry to provide a central enrolment record for all school students. The system is accessed at

www.leadspace.govt.nz

"Ministry" means the Ministry of Education.

"parent" means a person who is a student's mother, father, or guardian.

"principal" means the principal of a registered school.

"student" means a person enrolled in a registered school as a student, whether as a domestic student or an international student.

"task" means an action initiated by ENROL that a school must complete.

Rule 1 – Enrolling a student

- 1.1 When enrolling a student, every principal must ensure that:
 - a. ENROL is checked to confirm whether an enrolment record already exists for the student;

- ENROL is updated within 5 school days of the student attending the school. A student is not officially enrolled at the school unless indicated as such within ENROL;
- c. where a student, who is not a New Zealand citizen, Australian citizen or New Zealand resident, transfers to another school, ENROL is updated with:
 - the student's eligibility status;
 - the type of verification document used to verify the eligibility status and the serial number; and
 - the student's country of citizenship;
- d. where a student wishes to be enrolled under an alternative name, that name is entered in the "Aliases" field on the same enrolment record as the student's legal name;
- e. the principal liaises with the principal of another school if a student applying for enrolment is still enrolled at and attending that other school; and
- f. the principal checks whether, if the "Keep Information Private" checkbox is activated, this requirement should continue (Rule 5(i) explains when this checkbox should be used). If the principal clears this checkbox, then he or she must be satisfied that the parent has authorised this.

Rule 2 – Creating records in ENROL

- 2.1 Every principal must ensure that new ENROL records are created only for:
 - new entrants; or
 - international students entering a New Zealand school for the first time; or
 - students who are returning to the New Zealand school system from overseas who have not previously attended a New Zealand school since ENROL has been in use.
- 2.2 When creating a new ENROL record for a student, every principal must ensure that the student does not have an existing record and that all the mandatory fields in the new record are completed.

Rule 3 – Updating ENROL when students leave school

- 3.1 Every principal must ensure that:
 - a. ENROL is updated within 5 school days with the applicable leaving reason(s), teaching and learning note(s) where necessary, and the last day of attendance when:
 - the school has been advised that the student is no longer attending the school;
 - the student has been absent for 20 school days without the principal being informed that the absence is only temporary; or
 - the student has been absent for fewer than 20 days but the principal has reasonable cause to believe they will not return to school;
 - supporting information is kept on the student's file in the school when teaching and learning notes are included on a student's ENROL record;
 - c. the names of students younger than 16 who are suspended or excluded remain on ENROL until the earliest of:
 - the day the student is enrolled at another school; or
 - the day the student is given an exemption under section 21 or 22 of the Education Act 1989;
 - d. the names of students who have turned 16 and who have been suspended remain on ENROL until the earliest of:

- the day the student is enrolled at another school;
- the day the student is expelled from the school; or
- the day the student leaves school; or
- 1 January after the student's 19th birthday;
- e. students that have applied for an exemption under section 21 or 22 of the Education Act 1989 remain on ENROL unless the exemption is approved by the Ministry. The Ministry will then update the student's record in ENROL with the last day of attendance at the school.

Rule 4 – Non-enrolment notifications

- 4.1 Every principal must ensure that:
 - a. the non-enrolment notification form is completed within 5 school days when a non-enrolment notification task is sent to a school from ENROL;
 - b. all contact details for the student held by the school, and any additional information (eg involvement with other agencies) that will assist with locating the student, are entered on the non-enrolment notification form. Comments must include information about what the school has done to resolve the student's non-attendance before the student withdrew from school.

Rule 5 - School and other user responsibilities

- 5.1 Every principal must ensure that:
 - a. ENROL is updated for all the school's students, which includes those students who are attending offsite centres such as: Kura Teina satellites, special education satellite classes, Teen Parent Units, Activity Centres, Alternative Education, and Regional Health Schools;
 - b. every student enrolled at the school is recorded in ENROL in accordance with these rules;
 - c. the data in ENROL relating to the students currently enrolled in the school is maintained accurately and promptly by the school's authorised users;
 - d. enrolment changes are updated in ENROL within 5 school days;
 - e. tasks generated by ENROL, which relate to a student enrolled or previously enrolled in the school, are completed as soon as possible, but in any case within 5 school days;
 - f. the Ministry is advised immediately when an authorised user no longer requires access to ENROL;
 - g. all reasonable steps are taken to ensure that school employees are aware of their obligations in respect of the appropriate use and protection of personal information in ENROL;
 - h. the school provides parents and students with the information brochure provided by the Ministry when the student enrols. The information brochure will explain:
 - the purpose of ENROL;
 - who the authorised users of ENROL are and their obligations and responsibilities in respect of their use of ENROL;
 - that information related to the student's enrolment will be available to the next school;
 - that parents and students are entitled to request access to and/or correction of their personal information held in ENROL from the current school of enrolment or the Ministry; and
 - students' entitlements and parents' obligations in respect of enrolment;

- i. the "Keep Information Private" checkbox is activated on the student's ENROL record where the principal has reasonable cause to believe that:
 - a relevant protection order under the Domestic Violence Act 1995 or a relevant restraining order under the Harassment Act 1997 is in place; or
 - the student or a family member is under a witness protection programme under the Evidence Act 1958; or
 - the student is likely to be at significant risk if the checkbox is not activated;
- j. authorised users at the school comply with all relevant legislation when responding to requests for information from a student or parent;
- k. the school's own enrolment record is completed and signed by the parent(s) and/or student;
- a copy of the school's enrolment form for the student is retained after the student has left the school in accordance with the School Records Retention/Disposal Schedule approved under the Public Records Act 2005;
- m. E19/22A forms for students who were enrolled under the previous paper system are retained after the students have left the school in accordance with the School Records Retention/Disposal Schedule approved under the Public Records Act 2005;
- n. authorised users at the school use ENROL only for the purposes of:
 - facilitating the accurate and efficient enrolment of students; and
 - monitoring and ensuring student enrolment and attendance;
- authorised users do not share a user logon or password with any other person and the password is protected to prevent unauthorised access to the system;
- p. authorised users who are from a district health board use ENROL only for the purpose of updating a student's enrolment record with hearing and vision test results.

Rule 6 – Schools exempt from using ENROL

- 6.1 These rules apply to the principals of all schools except for those that have received a written exemption from the Secretary for Education.

Waste Minimisation Act 2008

Criteria for the Waste Minimisation Fund

The Waste Minimisation Fund was established to fund projects that promote or achieve waste minimisation.

Section 38 of the Waste Minimisation Act 2008 provides that the Minister for the Environment may set or vary criteria for approving funding of a project.

Pursuant to section 38 of the Waste Minimisation Act 2008, I, The Honourable Dr Nick Smith, Minister for the Environment, set the following criteria for approving funding of projects from the Waste Minimisation Fund.

I have obtained and considered the advice of the Waste Advisory Board prior to setting these criteria.

Criteria for the Waste Minimisation Fund Purpose of the Fund

The purpose of the Waste Minimisation Fund is to boost New Zealand's performance in waste minimisation.

There is considerable scope to reduce waste and increase the recovery of useful resources from waste.

Lifting our performance in recovering economic value from waste also provides environmental, social and cultural benefits and reduces the risks of harm from waste.

This will require investment in infrastructure and systems for waste minimisation and developing educational and promotional capacity.

The purpose of the fund is to provide some of the funding to ensure that this occurs.

Criteria

Eligibility - Waste Minimisation Projects

 Only waste minimisation projects are eligible for funding. Projects must promote or achieve waste minimisation. Waste minimisation covers the reduction of waste and the reuse, recycling and recovery of waste and diverted material. The scope of the fund includes educational projects that promote waste minimisation activity.

- Projects must result in new waste minimisation activity, either by implementing new initiatives or a significant expansion in the scope or coverage of existing activities.
- 3. Funding is not for the ongoing financial support of existing activities, nor is it for the running costs of the existing activities of organisations, individuals, councils or firms.
- 4. Projects should be for a discrete timeframe of up to three years, after which the project objectives will have been achieved and, where appropriate, the initiative will become self-funding.
- 5. Funding can be for operational or capital expenditure required to undertake a project.
- 6. For projects where alternative, more suitable, Government funding streams are available (such as the Sustainable Management Fund, the Contaminated Sites Remediation Fund, or research funding from the Foundation for Research, Science and Technology), applicants should apply to these funding sources before applying to the Waste Minimisation Fund.
- 7. The applicant must be a legal entity.
- 8. The fund will not cover the entire cost of the project. Applicants will need part funding from other sources.
- 9. The minimum grant for feasibility studies will be \$10,000.00. The minimum grant for other projects will be \$50,000.00.

Assessment Criteria

Project Benefits

- 1. Preference will be given to projects that collectively give the largest net benefit over time. The assessment of the effectiveness of projects will include the extent to which the projects can demonstrate:
 - likelihood of success;
 - reduction of harm to the environment;
 - reduction in the volume of waste disposed of;
 - economic, environmental, social or cultural benefits;
 - longer term benefits after the completion of the project.
- 2. Projects will be assessed for their strategic value in achieving the purpose of the fund. Strategic value means the likely ability of projects to act as catalysts that enhance and extend the uptake of waste minimisation.
- The degree of partnership and cross-sectoral collaboration will be taken into account in assessing the strategic value of proposals.
- 4. The level of funding from other sources will be taken into account. Shared funding is preferred.

Project Delivery

- 5. The applicant must demonstrate:
 - ability to deliver the project;
 - how the project will achieve its goals;
 - how the effectiveness of the project will be monitored, evaluated and reported;
 - if and how the project will be used to promote waste minimisation to the wider public;
 - if and how the project will continue after funding ends and become self sustaining, particularly if the funding is for the establishment phase of a longer term project.

Fisheries (Kaimoana Customary Fishing) Regulations 1998

Fisheries (Kaimoana Customary Fishing) Notice (No. 8) 2009 (No. F502)

Pursuant to Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the Programme Manager (Deed of Settlement Implementation Programme) at the Ministry of Fisheries (acting pursuant to a delegated authority in accordance with section 41 of the State Sector Act 1988) gives the following notice.

Notice

- **1. Title and commencement**—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 8) 2009.
- (2) This notice shall come into effect on 9 October 2009.
- **2. Interpretation**—In this notice:
 - (a) "mahinga mātaitai" are local dialect words that have the same meaning as "customary food-gathering", a term that is defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
 - (b) "Kaitiaki" is a local dialect word that has the same meaning as "Tangata Kaitiaki/Tiaki", a term that is defined in Regulation 2 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998.
 - (c) "Kaitiaki" means the person or persons appointed under Regulation 9 of the Fisheries (Kaimoana Customary Fishing) Regulations 1998 for the management of mahinga mātaitai within the area/rohe moana
 - (d) "area/rohe moana" means the area described by a line commencing:
 - (i) at a point on the coastline at Paritu (38°57.0'S and 177°54.2'E); then
 - (ii) due east for 200 nautical miles to a point (38°57.0'S and 177°25.0'W); then
 - (iii) due south to a point (43°15.0'S and 177°25.0'W); then
 - (iv) 45° north-west to a point ($39^{\circ}18.6'S$ and $177^{\circ}45.0'E$); then
 - (v) due north to a point (39°13.3'S and 177°44.9'E); then
 - (vi) generally north-easterly to a point on the coastline at Waikokopu (39°04.4'S and 177°49.6'E); then
 - (vii) generally northerly along the mean high-water springs mark to the point of commencement.

The geographical coordinates named are in terms of the WGS84 datum.

- **3. Nomination of Kaitiaki**—The Mahia Māori Committee, acting for the whānau, hapū and marae of Rongomaiwahine, has nominated Arthur Bowen and Alfred Spark as additional Kaitiaki for managing mahinga mātaitai within the area/rohe moana.
- **4. Appointment of Kaitiaki**—On 15 September 2009, the Minister of Fisheries confirmed, under Regulation 9(1) of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the appointment of Arthur Bowen and Alfred Spark as Kaitiaki for managing mahinga mātaitai within the area/rohe moana.

- **5.** Confirmation of tangata whenua—The whānau, hapū and marae of Rongomaiwahine, as represented by the Mahia Māori Committee, are confirmed as the tangata whenua of the area/rohe moana to which the appointment of Kaitiaki relates.
- **6. Power to authorise the taking of fisheries resources for mahinga mātaitai**—A Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Act 1996 for mahinga mātaitai purposes from

In accordance with section 161(2) of the Land Transport Act 1998, the NZ Transport Agency, on behalf of the Minister of Transport, gives notice of the Minister's intention to make a Rule to amend *Land Transport (Road User) Rule 2004* (Rule 61001).

The proposed amendment Rule, Land Transport (Road User) Amendment Rule (No 2) 2009 (Rule 61001/5) will allow a driver to use a mobile phone for any purpose other than a text message, video message, email or similar communication, provided that the phone is secured in a mounting that is fixed to the vehicle and the driver manipulates the phone infrequently and briefly.

Under Land Transport (Road User) Amendment Rule 2009 (Rule 61001/4), which, from 1 November 2009, will prohibit the use of hand-held mobile phones while driving, the use of a mobile phone's satellite navigation (Sat-Nav) function, or listening to stored audio or the radio on a mobile phone while driving, would not be allowed. The proposed amendment will allow mobile phones to be used for these purposes while driving.

Pipfruit Levy

Pipfruit growers and collection agents are advised that, pursuant to the Commodity Levies (Pipfruit) Order 2006, the levy rate for the levy year ending on 31 October 2010 was fixed at the annual general meeting held on 29 July 2009 at 1.25 cents per kilogram of whole fresh fruit (plus GST).

A "grower" means the occupier of land that is used for growing pipfruit, from which there was harvested at least 1000 kilograms of pipfruit during the 12 months ending with the previous 31st day of October.

Growers are responsible overall for ensuring that levies are deducted from sale payments and that the correct amounts are submitted to Pipfruit New Zealand Incorporated ("Pipfruit NZ").

A "collection agent" means a person whose business is or includes buying pipfruit from a grower for resale or export, or selling or exporting pipfruit on behalf of a grower.

Collection agents are required to deduct the levy from payments due to growers and forward these amounts to Pipfruit NZ within 90 days of sale or export.
