### **Anti-Money Laundering and Countering Financing of Terrorism Act 2009**

### Ministerial Exemptions Under the Anti-Money Laundering and Countering Financing of Terrorism Act 2009

In accordance with section 159(3) of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 ("AML/CFT Act"), the Minister of Justice hereby gives notice that she has granted the following exemptions from the AML/CFT Act:

Ministerial Exemption: Guardians of New Zealand Superannuation

- As the Minister of Justice, and pursuant to section 157
  of the AML/CFT Act, I exempt the Guardians of
  New Zealand Superannuation from all the provisions
  of this Act.
- 2. This exemption is not subject to any conditions.
- 3. This exemption will come into force on 30 June 2013.
- 4. This exemption will expire on 30 June 2018.

Ministerial Exemption: Casino loyalty schemes

- 1. As the Minister of Justice, and pursuant to section 157 of the AML/CFT Act, I exempt casinos as a class of reporting entities from the following provisions of the Act:
  - (a) Sections 14(a)–(c), 22(1)(a), 22(1)(a), 22(1)(b), 22(2) and 26 (customer due diligence); and
  - (b) section 31 (ongoing customer due diligence and account monitoring), subject to clause 4.

- 2. It is a condition of this exemption that the exemption only applies to a business relationship which is membership in a gaming loyalty scheme operated by a casino. For the purposes of this exemption, a gaming loyalty scheme is a scheme that:
  - (a) generates points or credit exclusively through:
    - (i) gambling; or
    - (ii) gambling and purchase of food and beverages; or
    - (iii) gambling and purchase of hotel accommodation;
    - (iv) gambling and purchase of food and beverages and hotel accommodation.
  - (b) meets the following criteria:
    - (i) A person cannot deposit funds or credit into a gaming loyalty scheme account or other loyalty arrangement or any associated loyalty card or instrument; and
    - (ii) a person can only hold one gaming loyalty scheme account or arrangement at a time and it is not transferable; and
    - (iii) the maximum value of points or credit where points or credit can be redeemed in cash in a gaming loyalty scheme account or arrangement is \$5,999.99; and
    - (iv) gaming loyalty scheme points or credit expire after 12 months from the date of the points accrual.
- 3. This exemption applies to gaming loyalty scheme cards or instruments that are used by a customer for the purpose of utilising membership in a gaming loyalty scheme. This exemption does not apply to other functions a gaming loyalty card or instrument may facilitate.

- 4. Exemption from account monitoring obligations applies only to the obligation to monitor the generation of loyalty points and the redemption of loyalty points. The exemption does not affect the obligation to conduct other account monitoring that might identify grounds for reporting a suspicious transaction.
- 5. The proposed exemption from account monitoring does not affect obligations under section 40 of the Act to report suspicious transactions.
- 6. This exemption will come into force on 30 June 2013.
- 7. This exemption will expire on **30 June 2018**.

### Social Security Act 1964

## Temporary Accommodation Assistance (Canterbury Earthquake) Amendment (No. 2) 2013

Pursuant to section 124(1)(d) of the Social Security Act 1964, the Minister for Social Development makes the following instrument.

### Instrument

- **1. Title**—This instrument is the Temporary Accommodation Assistance (Canterbury Earthquake) Amendment (No. 2) 2013.
- **2. Commencement**—This instrument comes into effect on the day after the date on which it is established and approved.
- **3. Principal programme**—This instrument amends the Temporary Accommodation Assistance (Canterbury Earthquake) Programme\* (the **principal programme**).
- **4.** Clause 5 amended (Interpretation)—(1) In clause 5(1), insert in their appropriate alphabetical order:
  - "arm's length transaction means a transaction that the parties would have entered into if they were:
  - (a) connected or related only by the transaction; and
  - (b) acting independently; and
  - (c) each acting in his or her or its own best interests".
  - "household, in relation to a person, means the person and the members of the person's family and other persons (not being boarders) usually residing with him or her; and members of the person's household has a corresponding meaning".
  - "member of the person's family, in relation to a person, includes any other person to whom the person is related by marriage, civil union, or de facto relationship".

- (2) In clause 5(1), definition of **temporary accommodation costs**, replace "his or her family who usually reside with the person", with "the person's household".
- (3) In clause 5(1), definition of **temporary accommodation costs**, paragraph (a), replace "the person", with "the person (A) from another person (not being the spouse or partner of A or any other joint owner or owner in common in respect of the affected premises (B) or B's spouse or partner) in an arm's length transaction".
- **5.** Clause 6 amended (Application of the Act)—In clause 6, replace "relocation" with "accommodation".
- **6. Clause 8 amended (Temporary accommodation assistance)**—(1) In clause 8(3), after "subject to", insert "subclause (3A) and".
- (2) In clause 8, after subclause (3), insert as new subclause (3A):
  - "(3A) For the avoidance of doubt, even if a person and 1 or more members of the person's household are the owners in respect of any affected premises jointly or in common, only 1 of those owners may be granted temporary accommodation assistance in respect of the temporary accommodation costs of the person and the members of the person's household."
- 7. Clause 9 amended (Rates of temporary accommodation assistance)—In clause 9, replace paragraphs (a) to (c) with:
  - "(a) for a person whose household comprises 3 or more people, \$330 a week;
  - (b) for a person whose household comprises 2 people, \$275 a week:
  - (c) for a person whose household comprises 1 person, \$180 a week."

#### Explanatory Note

This note is not part of this instrument, but is intended to indicate its general effect.

This instrument amends the Temporary Accommodation Assistance (Canterbury Earthquake) Programme to clarify its intent. In particular:

- clause 5 corrects a drafting error;
- clauses 7 and 4(2) amend the rates of temporary accommodation assistance in clause 9 of the programme to express them in terms of household size, and clause 4(1) inserts new definitions in clause 5 to clarify who is a member of a person's household;
- clause 4(3) amends the definition of temporary accommodation costs in clause 5 to clarify that it does not include rent paid to a spouse or partner, a co-owner of the affected premises, or a co-owner's spouse or partner, or in an arrangement that is not an arm's length transaction. Clause 5(1) inserts a definition of this term in clause 5;
- clause 6 inserts a new subclause (3A) in clause 8 to make it clear that where the affected premises are co-owned by a person and 1 or more members of the person's household, only 1 of the owners may be granted temporary accommodation assistance in respect of the temporary accommodation costs of the person and the members of the person's household.

Liable persons obliged to provide information under section 82 would have earned \$10 million or more from providing telecommunications services (such as voice, data or other services excluding broadcasting) by means of a component

of a public telecommunications network in the 2011/12 financial year.

Importantly, the \$10 million threshold can be met through revenue from a combination of liable persons where there is significant shareholding between two or more parties.

## Notice of the Electricity Industry Participation (Temporary Grid Reconfiguration) Code Amendment 2013

- 1. Pursuant to section 38(3)(b) of the Electricity Industry Act 2010 ("Act"), the Electricity Authority ("Authority") gives notice of the making of the Electricity Industry Participation (Temporary Grid Reconfiguration) Code Amendment 2013.
- The amendment is made urgently under section 40 of the Act. The amendment comes into force on 15 March 2013.
- 3. The amendment enables Transpower to temporarily remove interconnection assets from service or temporarily reconfigure the grid in specified circumstances where doing so results in a net benefit, to improve the operation of the electricity system.
- 4. The Authority considers that it is desirable to make the amendment urgently because:
  - (a) due to ongoing dry conditions in the lower South Island, inflows into the Waiau catchment area are extremely low and there is a risk of reaching the low operating range of Lake Te Anau and Lake Manapouri. When the absolute minimum of the low operating range of those lakes is reached, the output of Manapouri hydroelectric power station is restricted to inflows only. Under a continued low inflow scenario, the absolute minimum would be reached by about 15 April 2013;
  - (b) a temporary grid reconfiguration could provide a significant benefit by enabling increased transmission of electricity into Southland, which is needed to meet

- the daily Southland load in the conditions described above:
- (c) without the ability to temporarily reconfigure the grid, the system operator and Southland generators have less ability to manage the dry situation, which could expose consumers to rolling outages; and
- (d) a delay in making an amendment to the Electricity Industry Participation Code 2010 ("Code") will increase the likelihood that the benefits of a removal or reconfiguration of interconnection assets will not be realised.

**FMA** means the Financial Markets Authority established by Part 2 of the Financial Markets Authority Act 2011. **recognised exchange** means an authorised futures

**recognised exchange** means an authorised futures exchange under the Securities Markets Act or any exchange in a country other than New Zealand which is authorised by the laws of that country to operate as a futures exchange.

### wholesale person means any person:

- (a) who controls at least \$10 million; or
- (b) that is a trustee of a trust or a funds manager, acting in that capacity, who has under that person's control, as trustee or funds manager, net assets of at least \$10 million; or
- (c) who is authorised to carry on the business of dealing in futures contracts under the Act; or
- (d) who is authorised in another jurisdiction by the competent authority of that jurisdiction to deal in futures contracts; or

- (e) that is Her Majesty The Queen in right of New Zealand, a Crown entity named in the Crown Entities Act 2004, or a State enterprise named in the First or Second Schedule to the State-Owned Enterprises Act 1986 (each as amended from time to time); or
- (f) who is a statutory corporation or a registered bank; or
- (g) whose principal business is the investment of money or who, in the course of and for the purposes of their business, habitually invests money; or
- (h) who is a related body corporate of any of the persons mentioned in subparagraphs (a) to (g) above.
- (2) Any term or expression that is defined in the Act and used, but not defined, in this notice has the same meaning given to it by the Act.
- **3.** Authorisation for wholesale persons—(1) The company is authorised to carry on the business of dealing in futures contracts generally.
- (2) The authorisation in clause 3(1) is subject to the conditions that:
  - (a) the company deals only on behalf of wholesale persons; and
  - (b) before dealing in any futures contract in respect of which the authorisation applies, the company is satisfied on reasonable grounds that the wholesale person is contracting:
    - (i) as principal on its own account; or
    - (ii) on behalf of a related body corporate; or
    - (iii) a trustee of a trust or manager of a managed fund; and
  - (c) the terms of every futures contract in respect of which the authorisation applies, other than a futures contract which is made on or effected through a recognised futures exchange:
    - (i) create obligations that cannot be transferred (other than to a related body corporate of the company) or terminated by either party to the futures contract without the consent of the other party; and
    - (ii) require that any transfer of obligations under the futures contract can be made only to a person who meets the criteria described in paragraphs (a) and (b); and
  - (d) in respect of every futures contract the company enters into with a wholesale person as principal, the company makes available a guarantee from Fonterra in respect of its payment obligations under the futures contract;
  - (e) the company provides FMA with a copy of:
    - (i) Fonterra's audited annual financial statements (being its consolidated group financial statements) no later than three months after the end of Fonterra's financial year; and
    - (ii) unaudited financial statements of the company, which have been prepared internally as part of the process of preparing Fonterra's consolidated group financial statements, no later than three months after the end of Fonterra's financial year; and
  - (f) the company notifies FMA of any material matter concerning its authorisation as a futures dealer or its dealing pursuant to that authorisation.
- (3) The authorisation is also subject to the condition, in respect of any futures contract that is made on or effected

through a recognised exchange, that any acquisition or disposal of the contract is effected through a person who is an authorised participant or member of the recognised exchange and who is authorised or licensed by the laws of the country in which it operates to deal in future contracts and to hold client money for that purpose.

  - (c) one person appointed, in writing, by the South Taranaki District Council Chief Executive; and
  - (d) one person appointed, in writing, by the Stratford District Council Chief Executive; and
  - (e) one person appointed, in writing, by the New Plymouth District Council Chief Executive;
  - (f) one person appointed, in writing, by the Department of Conservation Director-General; and
  - (g) one person appointed by the committee as an independent member with recognised governance experience. The independent member will have the same rights as other members of the committee. The term of appointment will be in accordance with the Forest and Rural Fires Regulations 2005.
- (3) In the event that any appointment to be made under 4(2)(a) is not carried out within three months of the date by which the appointment should be made, the National Rural Fire Officer may appoint to the committee some fit person(s) who shall represent the interest of the organisations described in 4(2)(a).
