- alter the scope of some of the Rules to align with current practice or intended best practice to ensure the effective operation of the allocation process for the downstream reconciliation of gas quantities;
- clarify the scope of some of the existing provisions in the Rules;
- promote ease of understanding and interpretation; and
- resolve some minor drafting and wording issues or other minor matters, and provide greater consistency both within the Rules and between the Rules and other gas governance regulations and rules.

Section 43N(3) of the Act provides that Gas Industry Co is not required to comply with section 43N(1) (relating to an assessment) if it is satisfied that the effect of the

recommendation is only minor and will not adversely affect the interests of any person in a substantial way.

Gas Industry Co considers the recommendation satisfies the requirements of section 43N(3) and therefore no assessment under section 43N(1) has been made in respect of the recommendation.
