### Dumping and Countervailing Duties Act 1988

#### Reassessment of Anti-dumping Duty: Diaries From Kin Tai Printing Company Limited

- (d) “area/rohe moana” means the area described by a line commencing at a point on the southern bank of the Waikari River mouth (39°10.10'S 177°05.40'E); then proceeding generally south-east in a straight line to a point (39°21.40'S 177°11.90'E); then proceeding generally south in a straight line to a point (39°26.90'S 177°09.60'E); then proceeding generally west in a straight line to Bluff Hill

(39°28.90'S 176°55.20'E); then proceeding generally northerly following the mean high-water mark to the point of commencement. The geographical co-ordinates named are in terms of the WGS84 datum.

(e) “mātaaitai reserve” means:

- (i) the area encompassing those waters within a line beginning at Whirinaki Bluff-Te Uku (at 39°21.90'S and 176°54.10'E) south-east to a point 500 metres from the mean high-water mark (39°22.10'S and 176°54.40'E) and following that 500 metre limit in a northerly direction to a point (39°13.32'S and 177°2.63'E) then north-west to a point on the mean high-water mark 7 kilometres south from the Waikari River mouth (39°13.30'S and 177°02.10'E) and then generally south along the coastline to the point of commencement at Whirinaki Bluff-Te Uku; and
- (ii) the area encompassing those waters within 500 metres of a straight line between a point at 39°25.90'S and 176°57.50'E (being the North Pania Light Buoy) and a point at 39°27.56'S and 176°55.90'E (being the South Pania Light Buoy) including the two end points.

**3. Cancellation of appointments**—On 23 June 2009, the Minister of Fisheries cancelled, under Regulations 10(1)(a) and 26(1)(a) of the Fisheries (Kaimoana Customary Fishing) Regulations 1998, the appointment of Te Aranui Boyce Spooner as a Tangata Kaitiaki for the area/rohe moana and the mātaaitai reserve.

**4. Nomination of Tangata Kaitiaki**—(1) Ngāi Te Ruruku has nominated Ranui Toatoa as a replacement Tangata Kaitiaki for managing customary food-gathering within the area/rohe moana and for managing the mātaaitai reserve.

(2) Ngāi Te Ruruku has nominated Harry Tuapawa as an additional Tangata Kaitiaki for managing customary food-gathering within the Tīwhanui area.

**6. Power to authorise the taking of fisheries resources for customary food-gathering**—(1) A Tangata Kaitiaki appointed for an area/rohe moana may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken

in fresh water, for customary food-gathering purposes from within the whole or any part of an area/rohe moana. No customary food-gathering of fisheries resources may take place in an area/rohe moana without an authorisation from a Tangata Kaitiaki.

(2) A Tangata Kaitiaki appointed for a mātaihai reserve may authorise any individual to take fisheries resources managed under the Fisheries Act 1996, other than those resources that are taken in fresh water, for customary food-gathering purposes from within the whole or any part of a mātaihai reserve. No customary food-gathering of fisheries resources may take place in a mātaihai reserve without an authorisation from a Tangata Kaitiaki.

#### Electricity Act 1992

#### Notice of Making of Electricity Governance Amendment Rules (No. 74) 2009 and Notice of Reasons for Decision

1. Pursuant to section 172I of the Electricity Act 1992 ("Act"), I notify the amendment of the Electricity Governance Rules 2003 ("Rules") under section 172H of the Act.
2. The empowering provisions for the Electricity Governance Regulations in relation to which the amendments to the Rules are made are sections 172D(1)(3) and 172D(1)(4) of the Act.
3. The existing policy statement in Schedule C4 of Part C of the Rules will be replaced in its entirety with a new Schedule C4. The key changes include:
  - (a) new commitments by the System Operator:
    - (i) publishing temporary security constraints applied to schedules where those constraints have reached the "constraint percentage threshold" once new market systems are implemented. Publication will be within 10 minutes of the completion of the relevant schedule rather than within 10 minutes from the application of the constraint to the database;
    - (ii) publishing grid asset outage information used in the preparation of market schedules rather than within its publication of branch constraint information;
    - (iii) issuing a grid emergency notice if the System Operator considers a grid reconfiguration is required to mitigate a situation;
    - (iv) using reasonable endeavours to begin the preparation of a new security schedule at least once every two hours; and
    - (v) providing the information system with information from the week-ahead dispatch schedule once it completes such a schedule; and

(b) other changes include:

- (i) removing the requirement for the System Operator to publish transmission capability limits as these are available elsewhere;
  - (ii) providing more flexibility for the System Operator to choose the level of reserve required between 0–100% when there are insufficient generation and reserve offers;
  - (iii) removing specific conditions under which the System Operator will procure over frequency reserves for the South Island, giving it more flexibility to determine when it will procure the service and more accurately reflecting operational procedures used in the dispatch of over frequency reserves;
  - (iv) identifying the restoration of load following a loss of supply as an event in which a grid emergency might arise;
  - (v) no longer requiring the System Operator to send formal notices to every participant, only to those the System Operator believes may be able to assist in mitigating a grid emergency or will have a significant interest in the occurrence and nature of the grid emergency;
  - (vi) no longer requiring the System Operator to send separate Demand Allocation Notices but to permit including them in the relevant formal notice; and
  - (vii) rewording various clauses to remove obligations on asset owners where those obligations are already stated in Part C of the Rules (the policy statement should contain only commitments made by the System Operator).
4. Minor drafting amendments to various clauses have also been made, in reliance on section 172F(3) of the Act.
  5. Pursuant to section 172Z(4) of the Act, the reasons for my decision to amend the Rules are that:
    - (a) the changes contained in the new Schedule C4 improve the policies and means the System Operator employs to meet the principal performance obligations; and
    - (b) the new policy statement complies with the requirement in the Rules to review the policy statement annually.

6. These rules come into force on 1 September 2009.

##### Australia New Zealand Food Standards Code – Amendment No. 110 – 2009

##### Food Standards Australia New Zealand Act 1991

##### Preamble

The variations set forth in the Schedule below are variations to Standards in the *Australia New Zealand Food Standards Code* published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, which have been varied from time to time.

##### Citation

These variations may be collectively known as the *Australia New Zealand Food Standards Code* – Amendment No. 110 – 2009.

##### Commencement

These variations commence on 16 July 2009.

#### SCHEDULE

[1] *Standard 1.2.4 is varied by inserting after paragraph 2(a) –*

(aa) the food is water presented in packaged form as standardised in Standard 2.6.2;

[2] *Standard 1.3.3 is varied by –*

[2.1] *omitting clause 11, substituting –*

#### 11 Permitted processing aids used in packaged water and in water used as an ingredient in other foods

Subject to any qualifications in the Table to this clause, the processing aids listed in the Table may be used in the course of manufacture of packaged water and in water used as an ingredient in other foods provided the final food contains no more than the corresponding maximum permitted level specified in the Table.

[2.2] *omitting from the Table to clause 11 –*

Hydrofluorosilic acid (fluorosilic acid)	GMP
Sodium fluoride	1.5
Sodium fluorosilicate (Sodium silicofluoride)	1.5

*substituting –*

Hydrofluorosilic acid (fluorosilic acid) (only in water used as an ingredient in other foods)	1.5 (as fluoride)

[2.3] *inserting after the Table to clause 11 –*

##### Editorial note:

This clause contains the permissions for fluoride to be used in water that is used as an ingredient in other foods, but not in water presented in packaged form. Standard 2.6.2 contains a voluntary permission to add fluoride to water presented in packaged form.

[3] *Standard 2.6.2 is varied by –*

[3.1] *omitting the Purpose, substituting –*

This Standard deals with packaged waters and water-based beverages which contain food additives and in certain cases, nutritive substances. The Standard defines a number of products and sets certain compositional requirements for packaged water, electrolyte drinks, brewed soft drinks and formulated beverages. The Standard also permits the voluntary addition of fluoride to water presented in packaged form.

Labelling requirements specific to electrolyte drinks and water presented in packaged form are included in this Standard. This Standard also prohibits the labelling or presentation of non-alcoholic beverages in such a way as to suggest the product is an alcoholic beverage.

[3.2] *omitting the entry for Fluoride from the Table to subclause 2(2), substituting –*

Fluoride (naturally occurring)	2.0 (calculated as F <sup>-</sup> )
--------------------------------	-------------------------------------

[3.3] *inserting after clause 2 –*

## 2A Addition of fluoride to packaged water

- (1) In this clause, **water suitable for added fluoride** means water presented in packaged form which –
  - (a) does not contain sugars, sweeteners, flavourings or other food; and
  - (b) is not carbonated.
- (2) Fluoride must not be added to water presented in packaged form except in accordance with this clause.
- (3) Fluoride may be added to water suitable for added fluoride provided that –
  - (a) the total amount of the naturally occurring and any added fluoride is no less than 0.6 mg/L and no more than 1 mg/L; and
  - (b) the form of fluoride added is –
    - (i) hydrofluorosilicic acid (fluorosilicic acid);
    - (ii) sodium fluoride; or
    - (iii) sodium fluorosilicate (sodium silicofluoride).

## 2B Labelling of packaged water

- (1) The label on water presented in packaged form with added fluoride must contain a statement to the effect that the product contains added fluoride.
- (2) Subject to subclause (3), the label on water presented in packaged form may include a typical analysis which lists the total concentration of any naturally occurring compound expressed in either mg/L or parts per million.
- (3) A typical analysis may also include added fluoride provided that only the total amount of the naturally occurring and added fluoride is specified.
- (4) A typical analysis which complies with subclauses (2) and (3) is not a nutrition claim for the purposes of Standard 1.2.8.

### **STANDARD 2.10.3 CHEWING GUM**

#### **Purpose**

This Standard regulates the addition of calcium to chewing gum containing no more than 0.2% residual sugars; the calcium claims which can be made in relation to chewing gum containing no more than 0.2% residual sugars and certain other labelling requirements.

#### **Table of Provisions**

- 1 Interpretation
- 2 Permitted addition of calcium
- 3 Calcium claim
- 4 Labelling requirements
- 5 Small packages

#### **Clauses**

##### **1 Interpretation**

In this Standard –

**calcium claim** means a claim about the presence of calcium in chewing gum.

**chewing gum suitable for added calcium** means chewing gum containing no more than 0.2% residual sugars.

**releasable calcium** means the amount of calcium released into the mouth during 20 minutes of chewing calculated using the following formula –

$$Ca_r = \frac{(Ca_o \times W_o) - (Ca_c \times W_c)}{W_o}$$

Where –

$Ca_r$  is the releasable calcium (mg/g of chewing gum)

$Ca_o$  is the original calcium concentration in the chewing gum (mg/g)

$W_o$  is the weight of the original chewing gum (g)

$Ca_c$  is the residual calcium in gum that has been chewed for 20 minutes (mg/g)

$W_c$  is the weight of the chewed gum (g).

#### **Editorial note:**

As a guide, procedures and apparatus for determining releasable constituents from chewing gum are published in the *British Pharmacopoeia* and the *European Pharmacopoeia*, and are under consideration for inclusion in the *United States Pharmacopoeia*.

**supplier making the claim** means the supplier who makes or includes on a label or in an advertisement a calcium claim.

## 2 Permitted addition of calcium

Chewing gum suitable for added calcium may contain added calcium provided that the calcium is in a permitted form specified in the Schedule to Standard 1.1.1.

## 3 Calcium claims

- (1) A calcium claim may be made only if –
  - (a) the chewing gum to which the claim relates is chewing gum suitable for added calcium; and
  - (b) the chewing gum contains no less than 80 mg (10% of the RDI) of releasable calcium per serve; and
  - (c) the maximum quantity claimed is no more than 200 mg (25% of the RDI) of releasable calcium per serve; and
  - (d) the supplier making the claim has records that substantiate the matters listed in paragraphs (b) and (c); and
  - (e) the supplier making the claim makes the records available to the relevant Authority upon request.
- (2) To avoid doubt, a claim to the effect that chewing gum is a good source of calcium or releasable calcium must not be made.

## 4 Labelling requirements

- (1) Where a calcium claim is made in relation to chewing gum suitable for added calcium, the nutrition information panel must also include –
  - (a) the average quantity of releasable calcium per serve; and
  - (b) the average quantity of releasable calcium per 100 g; and
  - (c) the proportion of the RDI (for calcium) of releasable calcium per serve; and
  - (d) a statement to the effect that the average quantity of calcium is released during 20 minutes of chewing.
- (2) Subclause (1) does not apply to chewing gum suitable for added calcium in a small package.

Standard 1.1.1 defines a 'nutrition information panel or panel' as a panel which complies with the requirements of Division 2 of Standard 1.2.8.

## 5 Small packages

- (1) Where a calcium claim is made in relation to chewing gum suitable for added calcium contained in a small package, the label must include the following calcium declaration –
  - (a) the average quantity of releasable calcium per serve; and
  - (b) the serving size; and
  - (c) the proportion of the RDI (for calcium) of releasable calcium per serve; and
  - (d) a statement to the effect that the average quantity of calcium is released during 20 minutes of chewing.

- (2) To avoid doubt, the declaration requirement in paragraph 8(1)(a) of Standard 1.2.8 does not apply to the calcium declaration in subclause (1).
- (3) The declaration required in subclause (1) need not be set out in the prescribed panel format.

**Editorial note:**

For the purposes of labelling, Standard 1.2.1 defines a ‘small package’ as a package with a surface area of less than 100 cm<sup>2</sup>.
