**4. Interpretation**—(1) Clause 2.1 is amended by inserting the following definitions in their appropriate alphabetical order:

“**course of study** means,—

- (a) in relation to a secondary school, a full-time course;
- (b) in relation to a tertiary provider, any aggregate of courses, classes, and work required for the completion of a degree, diploma, certificate, or other qualification awarded by that provider;”

“**national qualification framework** means the framework for national qualifications developed by the NZQA under section 253(1)(c) of the Education Act 1989;”

“**tertiary provider** means a university, polytechnic, college of education, wananga, private training establishment, or other education provider approved under the Education Act 1989 or to which that Act applies.”

(2) Clause 2.1 is amended by revoking the definition of **postgraduate course**.

**5. Allowances**—Clause 5.2.2 is amended:

- (a) by inserting the following paragraph before paragraph (b):

“(aa) for a course, or a course forming part of a course of study, if that course or course of study is classified under the national qualifications framework as level 4 or above; or”

- (b) by revoking paragraph (c).

**6. New clause inserted**—The programme is amended by inserting the following clause after clause 5:

“**5A Savings in respect of level 4 and above courses**

If a person has been granted an allowance under this Part in respect of a course that the person is undertaking on 28 May 2009 (**course A**), his or her entitlement to be granted and to receive allowances in respect of course A, or any subsequent course that is part of the same course of study as course A, must, until the close of 31 December 2011, be determined as if clause 5.2.2 did not contain paragraph (aa).”.

### Explanatory Note

*This note is not part of the instrument, but is intended to indicate its general effect.*

*This instrument, which comes into effect on 28 May 2009, amends the Training Incentive Allowance Programme.*

*It removes the eligibility of persons who undertake new national qualifications framework courses of level 4 and above to receive allowances under Part 1 of the programme.*

*A savings provision allows persons granted allowances in respect of level 4 or above courses that they are undertaking on 28 May 2009 to continue to be granted and to receive allowances in respect of that course, or any subsequent course that forms part of the same course of study (for example, a degree course), until the close of 31 December 2011.*

In order to lay, place, maintain and replace ground anchors and associated equipment, the Crown shall have the right for its servants, agents and workmen with any tools, implements, machinery or other equipment reasonably necessary to enter the Easement Land for the purposes of laying, placing, maintaining or replacing any ground anchor and its associated equipment subject to the conditions that as little disturbance as possible is caused to the Easement Land, that the Easement Land is restored as nearly as possible to its original condition and that any other damage done by reason of the aforesaid is repaired at the cost of the Crown to the satisfaction of the Owner in all things.
3. The Crown will, where possible, undertake any maintenance of the ground anchors or retaining wall from the face of the cut. The Owner shall not do anything on or about the Easement Land, which would require the ground anchors and associated equipment to be removed or where their efficiency would be reduced to the point where the stability of the wall they retain would be reduced to standards, which in the reasonable opinion of the Crown are unacceptable.
5. That the Owner shall not undertake or permit or cause to be erected any building or structure other than fences on the Easement Land.

6. Except with the prior written consent of the Crown and then only in accordance with such terms and conditions as it may impose in respect of such consent, the Owner shall not plant or cause to be planted any trees or shrubs on the Easement Land.

##### Scope for undertaking orthodontic procedures in dental hygiene practice

The scope for undertaking orthodontic procedures in dental hygiene practice is set out in the documented “Detailed Scope for Undertaking Orthodontic Procedures in Dental Hygiene Practice” produced and published from time to time by the Dental Council of New Zealand.

Dental hygienists with approved training, experience and competence in orthodontic procedures assist the dentist or orthodontist in implementing orthodontic treatment plans through performing such orthodontic procedures as taking impressions and making study models, inserting, and removing some orthodontic appliances, preparing teeth for bonding, removing bonding composite and banding cement and providing oral health education and advice on the care and maintenance of orthodontic appliances.

Dental hygienists who undertake orthodontic procedures practise:

- under the clinical guidance of a dentist or orthodontist who is responsible for the patient’s clinical care outcomes; and
- to a treatment plan prepared by a dentist or orthodontist for the patient concerned.

##### Prescribed Qualifications

- Bachelor of Health Science (Endorsement in Dental Hygiene), University of Otago, conferred from 2002 and registration in the Scope of Dental Hygiene Practice; or
- Bachelor of Oral Health, University of Otago and registration in the Scope of Dental Hygiene Practice; or
- Diploma in Dental Hygiene, University of Otago conferred from 2002 and registration in the Scope of Dental Hygiene Practice; or
