Dumping and Countervailing Duties Act 1988

Anti-dumping Duties: Notice that Anti-dumping Duties on Galvanised Wire From South Africa May Cease to Apply

Under section 14(9) of the Dumping and Countervailing Duties Act 1988 (“the Act”), anti-dumping duties imposed on galvanised wire from South Africa will cease to apply to those goods on **18 August 2013**, unless at that date the goods are subject to review under section 14(8) of the Act.

Any interested party that might request that the Chief Executive of the Ministry of Business, Innovation and Employment initiate a review before the cessation date referred to above, should be aware that positive evidence justifying the need for a review must be provided to the chief executive.

If an application is received which provides positive evidence justifying the need for a review, the chief executive must undertake and complete a review investigation within 180 days of initiation on whether the anti-dumping duties should continue to be applied.

Positive evidence justifying the need for a review would need to include reasons for believing that the expiration of anti-dumping duties would see the continuation or recurrence of dumping of galvanised wire from South Africa, and

for believing that such dumping would be likely to cause the continuation or recurrence of material injury to the New Zealand industry producing galvanised wire.

The reasons should be supported by evidence and not be based on mere allegations or assertions.

Research, Science, and Technology Act 2010

Criteria for the Assessment of Proposals for Capability in Independent Research Organisations Funding by the Science Board

1. Notice to the Science Board

In this notice I:

- (a) specify that the Science Board (“the Board”) is to make funding decisions on proposals for *Capability in Independent Research Organisations* funding under section 10(3)(b) of the Research, Science, and Technology Act 2010; and
- (b) set the criteria for the assessment of proposals for *Capability in Independent Research Organisations* funding under section 8(1) of the Research, Science, and Technology Act 2010.

2. Interpretation

In this notice:

independent research organisation means an organisation that:

- (a) is not a Crown entity (as defined in section 7 of the Crown Entities Act 2004);
- (b) operates as an independent legal entity and is not owned, or primarily funded by a Crown entity (as defined in the Crown Entities Act 2004) or a business;

- (c) primarily undertakes research, science and technology, or related activities that are not for the development of its own products and services;

nationally significant capability means capability to undertake research, science and technology, and related activities that, if it were lost, would have a demonstrable and significant negative impact on the ability to grow the economy, or to achieve key environmental, societal and health outcomes for New Zealanders.

3. Policy Objective

The policy objective of the *Capability in Independent Research Organisations* investment mechanism is to fund research, science and technology, and related activities that will support nationally significant capability in independent research organisations that has the potential to contribute to:

- (a) major economic, social, or environmental benefits for New Zealand; or
- (b) the mitigation of major risks to New Zealand's economy, environment, or society that the Government has a role in mitigating.

4. Vision Mātauranga Policy

The Vision Mātauranga policy aims to unlock the science and innovation potential of Māori knowledge, resources and people for the benefit of New Zealand. It focuses on four themes:

- (a) Indigenous innovation – contributing to economic growth through distinctive science and innovation;
- (b) Taiao/environment – achieving environmental sustainability through iwi and hapū relationships with land and sea;
- (c) Hauora/Health – improving health and social wellbeing; and
- (d) Mātauranga – exploring indigenous knowledge and science and innovation.

5. Science Board to Make Decisions on Proposals for Capability in Independent Research Organisations Funding

5.1 The Board will make funding decisions on proposals for *Capability in Independent Research Organisations* funding.

5.2 In making funding decisions on proposals for *Capability in Independent Research Organisations* funding, the Board may allocate funds from any the following research funds:

- (a) Biological Industries;
- (b) High Value Manufacturing and Services;
- (c) Energy and Minerals;
- (d) Environmental;
- (e) Hazards and Infrastructure;
- (f) Health and Society (except that funding that is administered by the Health Research Council).

5.3 The Board must make funding decisions on proposals for *Capability in Independent Research Organisations* funding in accordance with:

- (a) the Public Finance Act 1989 and the relevant Appropriation Acts for Vote Science and Innovation; and
- (b) the criteria set out in “Description of Funds within Vote RS&T”, Supplement to the *New Zealand Gazette*, 31 January 2011, No. 9, at page 200.

5.4 The Board may allocate funding under this notice for programmes of research, science and technology, and related activities of up to seven years, at which time the contracts will be reviewed and renegotiated, subject to a successful review and assessment against the judgement criteria detailed in clause 7 and subject to the proposal meeting the Eligibility Criteria in this notice.

6. Eligibility Criteria

6.1 For a proposal for *Capability in Independent Research Organisations* funding to be assessed against the criteria in clause 7, the proposal:

- (a) must be made by an independent research organisation that:
 - (i) has staff and infrastructure; of a sufficient scale and capacity to carry out the proposal; and
 - (ii) has demonstrated that it has linkages with end users of the research, science and technology, or related activities, which may include industry users or the public sector;
- (b) must not be for research, science and technology, or related activities that are able to be funded by a commodity or industry levy;
- (c) must be for research, science and technology, or related activities:
 - (i) that will support nationally significant capability that the independent research organisation holds;
 - (ii) that can only be provided by the independent research organisation due to its unique capability to undertake the research, science and technology, or related activities in the proposal; and
 - (iii) for which the independent research organisation has received Vote Science and Innovation funding of at least \$0.5 million per annum for more than one contestable funding round.

6.2 For the purposes of clause 6.1(c)(iii), an independent research organisation does not receive Vote Science and Innovation funding if it receives such funding indirectly through a third party rather than as a result of being the successful applicant in a proposal for funding in a contestable funding process.

7. Assessment Criteria

The Board must assess all proposals that meet the eligibility criteria in clause 6 against the following assessment criteria to determine whether they are of an acceptable standard to receive *Capability in Independent Research Organisations* funding:

- (a) The extent to which the proposal is likely to:
 - (i) contribute to New Zealand with major economic, social or environmental benefits or the mitigation of major risks to New Zealand's economy, society or environment; and, where relevant,
 - (ii) unlock the science and innovation potential of Māori knowledge, resources and people, in accordance with the aim of the Vision Mātauranga policy, in contributing to New Zealand with major economic, social or environmental benefits or the mitigation of major risks to New Zealand's economy, environment, or society;
- (b) the extent to which the proposal demonstrates a credible pathway to implementation of the results, which must include a description of:

- (i) who the end users are;
- (ii) how the independent research organisation will engage with end users; and
- (iii) how the research results will be taken up by end users;
- (c) the extent to which the independent research organisation making the proposal has the ability to deliver results (outputs) of research, science and technology, or related activities, having regard to:
 - (i) the track record of the independent research organisation and the staff involved;
 - (ii) the involvement of appropriate collaborators; and
 - (iii) the availability of appropriate infrastructure; and
- (6) the quality of the proposed research, science and technology, or related activities.

8. Weightings

The Board must apply the following weightings to the assessment criteria:

Assessment Criteria	Weighting
Economic, social, or environmental benefits or mitigates major risks to New Zealand	25%
Pathway to implementation	25%
Ability to deliver results (outputs) of research, science, and technology, or related activities	20%
Research quality	30%

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

Notice of Receipt of Pricing Review Applications for the UCLL Standard Terms Determination

The Commerce Commission ("Commission") gives notice that it has received applications for a review of the price set for the regulated service Chorus' unbundled copper local loop network.

The price for this service is regulated in the Commission's *Standard terms determination for the designated service Chorus's unbundled copper local loop network*, Commerce Commission Decision 609, 7 December 2007 ("the UCLL STD").

This notice is made under section 43 of the Telecommunications Act 2001 ("Act").

On 3 December 2012, the Commission released its *Final decision on the benchmarking review for the unbundled copper local loop service* ([2012] NZCC 37).

In that decision, the Commission determined the regulated prices for the UCLL service using international benchmarks, as required by the Act.

The Commission determined a geographically averaged UCLL monthly rental price of \$23.52, coming into effect on 1 December 2014.

The Commission also set urban and non-urban UCLL monthly rental prices of \$19.08 and \$35.20 respectively, coming into effect immediately.

New UCLL connection charges were also determined.

The determined price of the UCLL service also applies to the price for the regulated service Chorus' unbundled copper low frequency service, and is used to derive the prices for the sub-loop services set under the *Standard terms determination for Chorus' sub-loop unbundled copper local loop services*, Commerce Commission Decision 672, (18 June 2009).

The price of the UCLL service is also a component of the price for the regulated service Chorus' unbundled bitstream access (UBA).

The Commission has received four applications for a pricing review for the above-mentioned determination from parties under section 42 of the Act.

The Commission has also received an application from Telecom New Zealand Limited.

However, as Telecom is not currently a party to the UCLL STD, the Commission's initial view is that this application cannot be accepted.

Notice of Recommendation for Amendments to the Gas (Downstream Reconciliation) Rules 2008

This notice of a recommendation for amendments to the Gas (Downstream Reconciliation) Rules 2008 (“the Rules”) is issued by Gas Industry Company Limited (“Gas Industry Co”) approved as the industry body by Order in Council under section 43ZL of the Gas Act 1992 (“the Act”).

Section 43O of the Act provides that, after making a recommendation for a gas governance regulation to the

Minister of Energy and Resources (“the Minister”), Gas Industry Co must publicise the recommendation.

Recommendation

Following a review of the Rules and their operation, carried out between 2011 and 2012, Gas Industry Co made a recommendation to the Minister for a number of amendments to the Rules.

The effect of the recommended amendments is to:

- codify long-standing exemptions which arose due to unforeseen issues with the original drafting of the Rules, and required operational experience and analysis to resolve;
- reduce the compliance burden created by certain arrangements, where the cost of administering technical breaches outweighs the impact of those breaches; and

- address other operational issues identified by the industry group convened during the Rules review, to better achieve the purpose of the Rules.
