Electricity (Safety) Regulations 2010

Electricity Regulations (Prohibited Electrical Fitting – Outlet Device) Notice 2013

Pursuant to Regulation 87 of the Electricity (Safety) Regulations 2010 (“the Regulations”), I, Mark Stephen Wogan, Manager, Energy Safety, give the following notice.

Notice

1. Short title and commencement—(1) This notice is the Electricity Regulations (Prohibited Electrical Fitting – Outlet Device) Notice 2013.

(2) This prohibition is to take effect on and from the date following the date of publication of this notice in the *New Zealand Gazette*.

2. Prohibited equipment—The manufacture, importation, sale (including offer to sell), and use of the electrical fitting, being an Outlet Device as prescribed in this notice, is prohibited.

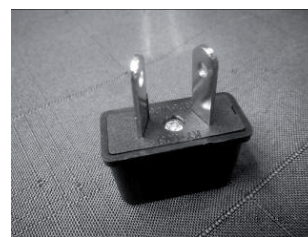
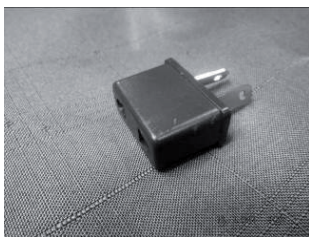
3. Description—(1) The fittings meeting the definition of an “Outlet Device” to which this notice applies are products generally known as “Plug Adaptors” or “Travel Adaptors” as further described below. The prohibited Outlet Devices have been sold on-line with electrical appliances, to allow their connection to the New Zealand type socket-outlets. The prohibited Outlet Devices are also likely to be, or have been, available elsewhere in New Zealand.

(2) The prohibited Outlet Device has a known marking that includes “KY-003 6 A 125V/250V”, although the prohibited fitting may also have different or no marking present.

(3) The approximate overall dimensions of the prohibited Outlet Device are: 3.3 x 1.5 x 4.1 cm.

(4) The prohibited Outlet Device has a plastic body, which has two un-parallel, un-insulated, metal plated flat plug pins with rounded ends, each of which has a central hole at the pin tip end. The body at the opposite end to the plug pins has two corresponding socket apertures intended to accommodate the plug pins of a non-New Zealand type plug. The plastic body colour can vary and the fitting body is in two parts that are held together with a single fixing screw.

(5) The images shown below are showing views of one sample of the prohibited Outlet Device for identification purposes:



4. Details of hazard—The prohibited Outlet Device may be electrically unsafe in that:

- the prohibited fitting has been known to come apart when inserted into a socket-outlet, leaving exposed live parts on the socket-outlet face. Therefore, the Outlet Device may constitute an electric shock hazard to anyone in the proximity of the socket-outlet into which the fitting has been inserted; and
- the prohibited Outlet Device allows an appliance plug to be incorrectly inserted into the fitting. This may constitute an electric shock hazard to the user, if they should incorrectly insert a single plug pin into the socket-outlet portion of the prohibited Outlet Device, as it is then possible to come into contact with the other plug pin that is exposed and may be live.

5. Reasons for prohibition—The prohibited Outlet Devices described in this notice are, or may be, electrically unsafe, in that there is significant risk that a person may suffer harm as a result of dangers arising from use of, or passage of electricity through, the fittings. The prohibited Outlet Devices are non-compliant in that:

- with respect to Regulation 80(2)(a) of the Regulations, the Outlet Devices do not comply with standards AS/NZS 3820 or AS/NZS 3122; and
- the Outlet Devices are electrically unsafe, as defined in Regulation 5 of the Regulations.

“SCHEDULE 4

COMMERCIALISATION AND TECHNOLOGY TRANSFER SUPPORT

The Science Board can use Objective 2 of this investment tool when making funding decisions.

POLICY OBJECTIVES

The objective of this tool is to increase the benefit to New Zealand derived from publicly funded research, science and technology outputs.

OBJECTIVE

The objectives of this tool are to improve the ability of:

1. research organisations to commercialise the results of their research, science and technology
 - via existing businesses and industry organisations, or
 - in the absence of a well-established industry, through the creation of new commercial entities; and
2. research users to access the skills, knowledge and results generated by publicly funded research, science and technology.

ELIGIBILITY CRITERIA

For Objective 1:

Research organisations are eligible to receive funding under this tool to support activities that develop publicly funded research, science and technology to an ‘investor ready’ point, including:

- Experimental development and related pre-commercial activities
- Activities that raise research providers’ commercial capabilities and skills
- Activities that improve links between publicly funded research providers and potential private sector partners.

For Objective 2:

Research, science and technology users are eligible to receive funding under this tool to support:

- improved science input from research organisations to their activities, including decision making;
- an increase in their engagement with the RS&T sector; and
- greater collective engagement between research users and the science system generally.

PARAMETERS SPECIFIC TO THIS TOOL

- For Objective 1, co-funding is required for funding going to research organisations and their offices
- Research users may include regional councils
- Some activities funded under this initiative may be devolved to research organisations.
- For Objective 1:
 - The Board, or a provider to whom the Board has devolved funds, will use the investment tool to fund a project, or portfolio of projects at an aggregate level, at up to 50% of the eligible costs that the provider will incur. Eligible costs mean the total costs of a project or a group of projects funded under this investment tool.
 - The provider may reprioritise existing funds allocated by the Board (or the entity previously called the Foundation for Research, Science and Technology), up to a maximum of 12.5% of eligible costs and with prior approval from the Ministry of Science and Innovation.

- The balance of the eligible costs may come from one or more of the sources listed below:
 - The provider's own discretionary funds;
 - Other external funds, such as private sector co-investment, but excluding non-research funds sourced from public sector funding agencies."

The Education (Domestic Students) Notice 2013

Pursuant to section 2(1) paragraph (c) of the definition of the term “domestic student” of the Education Act 1989, the Minister of Education, by and through Marilyn Scott, Acting Group Manager, Ministry of Education, acting under delegated authority, gives the following notice:

Notice

1. Title and commencement—(1) This notice may be cited as the Education (Domestic Students) Notice 2013.

(2) This notice shall come into force on the day after the date of its publication in the *New Zealand Gazette*.

2. Domestic students—Persons of the following class or description are required to be treated as if they are not international students:

- (a) A person who holds a student visa and who is the dependent child of any person who is in New Zealand to study under an exchange programme approved by the New Zealand Government.
- (b) A person who holds a student visa or a visitor visa and who is in New Zealand to study under an approved New Zealand student exchange scheme offered by a Code signatory school or offered by an approved exchange programme organisation.
- (c) A person who holds a student visa and who has entered New Zealand for the purposes of adoption and:
 - (i) whose adoption application before the New Zealand Family Court (where the Final Order will entitle that person to education as a domestic student) is supported by the Child, Youth and Family Service of the Ministry of Social Development and who has a letter from the service confirming that support; or
 - (ii) who is the subject of an Interim Order of Adoption granted by the New Zealand Family Court under section 5 of the Adoption Act 1955 (where the Final Order will entitle that person to education as a domestic student).
- (d) A person who holds a student visa and who is the dependent child of an international student who is

enrolled in a Doctor of Philosophy programme at a New Zealand university.

- (e) A person who is in the custody of the Chief Executive of the Ministry of Social Development pursuant to any of the following orders:
 - (i) An order, pursuant to sections 78, 101 or 238(1)(d) of the Children, Young Persons, and Their Families Act 1989, in favour of the Chief Executive of the Ministry of Social Development;
 - (ii) An order, pursuant to section 110 of the Children, Young Persons, and Their Families Act 1989, appointing the Chief Executive of the Ministry of Social Development as sole guardian;
 - (iii) An order, pursuant to section 33 of the Care of Children Act 2004, whereby a child or young person is placed under the guardianship of the Family Court or the High Court and the Chief Executive of the Ministry of Social Development is appointed as agent of the Court with power and discretion to place the child.
- (f) A person who holds a student visa and who is the dependent child of an international student who is supported by a scholarship funded by the New Zealand Aid Programme administered by the Ministry of Foreign Affairs and Trade.
- (g) A person who has a letter from the Protocol Division of the Ministry of Foreign Affairs and Trade confirming that he or she is, for the time being, entitled to any immunity from jurisdiction by or under the Diplomatic Privileges and Immunities Act 1968 or the Consular Privileges and Immunities Act 1971 for the current school year, until the end of the year in which that status expires.
- (h) A person who holds a student visa and who is the dependent child of the holder of a valid military visa.
- (i) A person who has, or who is the dependent child of any person who has, made a claim to be recognised as a refugee or a protected person in accordance with Part 5 of the Immigration Act 2009, and who is the holder of a valid temporary visa.
- (j) A person who has, or who is the dependent child of any person who has, been recognised as a refugee or a protected person in accordance with Part 5 of the Immigration Act 2009, and whose application for residence is being processed.
- (k) A person who holds a student visa and who is the dependent child of any person who is a New Zealand citizen or the holder of a residence permit under the Immigration Act 1987 or of a residence class visa under the Immigration Act 2009 and:
 - (i) whose own application for a residence class visa under the Immigration Act 2009 has been received and is being considered for approval by Immigration New Zealand at the time the student enrolls; or
 - (ii) whose own application for citizenship is being considered for approval by the Department for Internal Affairs, until the end of the year in which the student visa expires.
- (l) A person who holds a student visa and who is the dependent child of a person who is the holder of a work visa until the end of the year in which the work visa expires.
- (m) A child who has been certified by the New Zealand police as a victim of people trafficking and who

holds an unexpired temporary visa granted under the Immigration New Zealand "Child Victims of People Trafficking" policy.

- (n) A child who is unlawfully in New Zealand and who holds an unexpired approval from the Ministry of Education confirming that he or she meets all of the following criteria:

- (i) At the date of application, either the child and the parent have been ordinarily resident and living together in New Zealand continuously for over six months or, in the case of a child whose most recent arrival in New Zealand was before 23 August 2011, the child and the parent or the child and an extended family member have been ordinarily resident and living together in New Zealand continuously for over six months.
- (ii) Either the child has not been previously enrolled at a New Zealand registered school or other provider within the meaning of section 238D of the Education Act 1989, or the child's most recent enrolment was as a domestic student.
- (iii) Except for those children listed in paragraphs (A) or (B) below, the child's last visa was not a student visa or student permit, an interim visa with study conditions, a visitor visa or a limited purpose permit or limited visa:
 - (A) Children who last held a student visa or student permit and whose most recent enrolment at a registered school was as a domestic student.
 - (B) Children whose most recent arrival in New Zealand was before 23 August 2011.

3. Interpretation and transitional provisions—(1) For the purposes of paragraph (b) of clause 2 of this notice, an approved New Zealand student exchange scheme or an approved exchange programme organisation means a scheme or organisation holding an unexpired approval from the Ministry of Education dated on or after 1 July 2012.

(2) Until 1 July 2013, a student exchange scheme or an exchange programme organisation approved by the Ministry of Education before 1 July 2012 is deemed to be an approved New Zealand student exchange scheme or an approved exchange programme organisation for the purposes of subclause (1) of this clause.

(3) Any scheme or organisation with deemed approval under subclause (2) of this clause must apply to the Ministry of Education to continue their approval beyond 1 July 2013.

(4) For the purposes of paragraph (n)(i) of clause 2 of this notice:

parent means the child's mother, father or legal guardian;

legal guardian means the person:

- (a) with the legal right and responsibility to provide for the care (including education and health) of the child and appointed by a New Zealand or foreign Court or by testament; and
- (b) providing for the care of the child in the child's home country.

(5) The references to a student visa, a military visa, or a work visa in clause 2 of this notice include an interim visa letter from Immigration New Zealand which continues the visa type and conditions of that student, military or work visa, until the end of the period stated in the interim letter.

4. Revocation—This notice revokes the Education (Domestic Students) Notice 2012 published in the *New Zealand Gazette*, 14 June 2012, No. 67, page 1859.

The Public Trust Common Fund Interest Rates Notice 25 January 2013

Notice

1. Title and commencement—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 25 January 2013.

(2) Unless otherwise specified, the determinations and revocation in this notice take effect from and including 25 January 2013.

2. Interpretation—(1) Unless the context otherwise requires:

“agency deposit” means a deposit (not being an investment deposit) held as agent or attorney;

“call deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

“deposit” means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 6 December 2012 is revoked.

(2) Unless otherwise specified, the rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 24 January 2013 but otherwise operate as from 25 January 2013.

The levy rate will be (excluding GST):

- (a) base levy of \$20.00; and
- (b) apiary levy of \$14.00 per apiary.

However, as stated in clause 7(4), if a beekeeper owns fewer than 11 beehives on fewer than four apiaries, the sum of the number of registered apiaries must be treated as one.

(3) This notice revokes all previous Osteopathic Council fees and disciplinary levy notices.

Notice of Scopes of Practice and Related Qualifications Prescribed by the Osteopathic Council

This notice replaces the Notice of Scopes of Practice and Related Qualifications Prescribed by the Osteopathic Council dated the 20th day of October 2011 and published in the *New Zealand Gazette*, 20 October 2011, No. 159, page 4569.

This notice will take effect from **31 January 2013**.

Scopes of Practice

Pursuant to section 11(1) of the Health Practitioners Competence Assurance Act 2003 (“the Act”), the Osteopathic Council (“the Council”) specifies the following scopes of practice:

1. General Osteopathic Scope of Practice

All registrants currently registered in the Scope of Practice: Osteopath will, from 31 January 2013, become registered in the General Osteopathic Scope of Practice.

Osteopaths are primary healthcare practitioners. Central to the competent practice of osteopathy is an understanding of the role of the primary care team and referral routes within the primary care team and to hospital based services.

Osteopathy is a person-centred form of manual medicine informed by osteopathic principles. Osteopathic medicine is not confined to historical osteopathic knowledge; rather osteopathic philosophies and concepts inform the interpretation and application of interdisciplinary knowledge and the basic medical sciences. Osteopathic medicine is an evolving field of knowledge and incorporates new concepts as our understanding of health and disease progresses.

Osteopaths treat people and conceptualise health and disease within a broad holistic bio-psycho-social and environmental context. Osteopaths have a particular interest in conditions of the neuro-musculoskeletal system and the management of pain. Osteopaths seek to prevent disease and promote health by empowering patients through sharing knowledge on lifestyle choices that improve health outcomes.

Osteopathic practice may be situated within a continuum of healthcare and wellness, with osteopaths applying evidence-based approaches to the management of named pathologies and conditions through to promoting well-being through supportive treatment.

The competent practice of osteopathy clearly requires broad diagnostic competencies and a differential diagnosis is required to determine if a structural diagnosis and the use of osteopathic manual treatment (OMT) is appropriate. Although osteopathic practice is often defined by OMT, the practice of osteopathy is not limited to a structural diagnosis and OMT. Whilst there may well be a somatic component to disease, OMT may not be indicated or the principal modality in every presentation.

Osteopaths work across the lifespan and may treat individuals from birth to old age, or deliver services in group settings. Professional knowledge may be applied in a range of settings not limited to clinical practice, such as health promotion, education and research, health policy and healthcare management.

Protection of Title: Those registered in the General Osteopathic Scope of Practice are entitled to use the title of osteopath.

The formulation of the Osteopathic Principles endorsed by the Council as underlying the above scope of practice may be found on the Council's website www.osteopathiccouncil.org.nz

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the General Osteopathic Scope of Practice:

All applicants must:

- (1) hold a Master of Osteopathy awarded by Unitec New Zealand;
or
- (b) hold a Master of Osteopathy awarded by Royal Melbourne Institute of Technology or Victoria University, Melbourne, or Southern Cross University, New South Wales, Australia, provided those qualifications remain accredited by the Australian and New Zealand Osteopathic Council;
or
- (3) pass the overseas assessment process endorsed by the Council;
or
- (4) be registered under the Competent Authority Pathway endorsed by the Council, which means that an applicant is registered with the General Osteopathic Council of the United Kingdom and holds a qualification from one of the following institutions:
 - British College of Osteopathic Medicine (as validated by the University of Westminster since 9 May 2000);
 - British School of Osteopathy (as validated by the University of Luton since 9 May 2000);
 - College of Osteopaths (as validated by Keele University since 1 September 2007);
 - College of Osteopaths (as validated by Middlesex University since 1 October 2001);
 - European School of Osteopathy (as validated by the University of Greenwich since 9 May 2000);
 - Leeds Metropolitan University (since 1 September 2007);
 - London College of Osteopathic Medicine (since 1 October 2001);
 - London School of Osteopathy (as validated by the University of Brighton or Anglia Ruskin University since 9 May 2000);
 - Oxford Brookes University (since 1 October 2003);
 - Surrey Institute of Osteopathic Medicine (as validated by the University of Surrey since 1 January 2003).

2. Extended Scopes of Practice

The purpose of an extended scope of practice is to permit holders of the general osteopathic scope of practice to extend their clinical skills. ***The Council wishes to make explicit that the prescribed qualification for the general osteopathic scope of practice is not adequate to ensure competent practice and protect the health and safety of the public for areas of practice where an extended scope has been developed.***

Only those that are registered in the extended **Scope of Practice: Western Medical Acupuncture and Related Needling Techniques** and have maintained a current annual practising certificate may lawfully incorporate the relevant techniques or approaches into his or her practice.

Scope of Practice: Western Medical Acupuncture and Related Needling Techniques

All registrants previously registered in the Scope of Practice for Osteopaths using Western Medical Acupuncture and Related Needling Techniques will, from the date this notice takes effect, become registered in the Western Medical Acupuncture and Related Needling Techniques Scope of Practice

Osteopaths registered in the Scope of Practice: Western Medical Acupuncture and Related Needling Techniques are primary healthcare practitioners who hold the General Osteopathic Scope of Practice, and who are qualified to perform Western medical acupuncture and related needling techniques, such as "dry-needling", intra-muscular stimulation or other skin penetrating techniques using a fine filiform (acupuncture) needle.

Western medical acupuncture (WMA) is a therapeutic modality involving the insertion of fine needles; it evolved from traditional based acupuncture systems. Its practitioners no longer adhere to concepts such as Yin/Yang and circulation of qi, and regard acupuncture as a modality rather than a complete "alternative medical system". WMA is an evolving

inter-disciplinary form of practice drawing on contemporary knowledge of anatomy, physiology and pathology, and the principles of evidence based medicine rather than traditional systems of knowledge. It is mainly used to treat musculoskeletal pain (including myofascial trigger point pain), postoperative pain and nausea. Holders of the scope are bound to practise according to the Code of Practice for Osteopaths using Western Medical Acupuncture and Related Needling Techniques.

Protection of Title: Those registered in the Scope of Practice Western Medical Acupuncture and Related Needling Techniques are entitled to use the title of **Osteopathic - Western Medical Acupuncture Practitioner**.

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Scope of Practice: Western Medical Acupuncture and Related Needling Techniques.

All applicants must:

- (1) hold one of the qualifications prescribed for registration in the Scope of Practice – Osteopath;

and

- (2) hold one of the following qualifications:

Post Graduate Certificate in Western Acupuncture, Auckland University of Technology

Post Graduate Certificate in Western Medical Acupuncture, University of Hertfordshire (United Kingdom);

or in addition to paragraph (1) above

- (3) in accordance with section 15(2) of the Act, satisfy the Council that they hold an overseas qualification that is, in the opinion of the Council, equivalent to, or as satisfactory as, one of the qualifications prescribed in paragraph (2) above. If necessary in the opinion of the Council, the applicant will be required to complete further training in Western medical acupuncture.

3. Vocational Scopes of Practice: Gerontology and Pain Management

The purpose of a vocational scope is to allow members of the public / referring healthcare professionals to identify osteopaths on the Register with advanced standing in a sub-domain of practice. Council recognises that there is a continuum of skill and expertise acceptable in the area of practice and *it is explicit that the pre-professional training / registration in the General Osteopathic Scope of Practice gives the registrant adequate skills to be competent* but that mastery of a particular area of practice may develop overtime and with further study. The vocational scopes allow post-graduate study combined with clinical experience to be reflected on the Register. Patients and referring healthcare professionals will be able to identify registrants that are well suited to meet the particular healthcare needs of patients.

Gerontology

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Gerontology Scope of Practice.

All applicants must:

- (1) be registered in the General Osteopathic Scope of Practice;

and

- (2) hold one of the following qualifications:

Postgraduate Diploma in Health Science in Older Adult: Health and Wellness, Auckland University of Technology or other courses of study at New Zealand tertiary institutions deemed by Council to be of similar standard and content (Current registrants who possess relevant tertiary qualifications that are not prescribed may make an application to Council up until date **31 December 2015**. Council may grant registration in the scope or recommend further study.);

or

- (3) in addition to paragraph (1) above, and in accordance with section 15(2) of the Act, satisfy the Council that they hold an overseas qualification that is, in the opinion of the Council, equivalent to, or as satisfactory as, one of the qualifications prescribed in paragraph (2) above. If necessary in the opinion of the Council, the applicant will be required to complete further training in gerontology.

Pain Management

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Pain Management Scope of Practice.

All applicants must:

- (1) be registered in the General Osteopathic Scope of Practice;

and

- (2) hold one of the following qualifications:

Postgraduate Diploma in Health Science endorsed in Pain & Pain Management, Department of Musculoskeletal Medicine, Otago University (Christchurch), or other courses of study at New Zealand tertiary institutions deemed by Council to be of similar standard and content (Current registrants who possess relevant tertiary qualifications that are not prescribed may make an application to Council up until date **31 December 2015**. Council may grant registration in the scope or recommend further study.);

or

- (3) (in addition to paragraph (1) above, and in accordance with section 15(2) of the Act, satisfy the Council that they hold an overseas qualification that is, in the opinion of the Council, equivalent to, or as satisfactory as, one of the qualifications prescribed in paragraph (2) above. If necessary in the opinion of the Council, the applicant will be required to complete further training in pain management.

4. Special Purpose Scopes of Practice

The Osteopathic Council recognises that osteopathic practice is not limited to the direct provision of clinical services to patients. By recognising that activities other than clinical practice are legitimate applications of professional knowledge osteopaths are permitted to remain on the Register with a practising certificate.

Council will be able to acknowledge their contribution to healthcare and allow systems to be developed that do not penalise such individuals by imposing recency of practice requirements, professional development or recertification programmes that are not relevant to their area of professional practice. It is not the Council's intention to create an additional protected title for this scope.

Holders of this scope may be required to engage with a return to competence programme if they have not engaged in clinical practice for three subsequent years and wish to return to clinical work. Council will use its discretion to determine how the scope holders' activities might have contributed to the maintenance of competence in terms of clinical practice.

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Special Purpose Scope of Practice.

To be granted the special purpose scope, a registrant will need to have been previously registered in the general osteopathic scope of practice, or meet the requirements for general registration and satisfy the Council that they have advanced standing or specialist skills in one of the designated areas:

1. Direct non-clinical relationships with patients such as in group exercise programmes, health promotion activities or health care management.
2. Clinical educators / clinical preceptors in pre-professional teaching clinics or practice-based settings.
3. Research – undertaking or directing research activities.
4. Teaching – faculty work in the tertiary sector on professional qualifications that will lead to registration as an osteopath or other regulated health professional and post graduate osteopathic / health science programmes.
5. Health policy development and regulation.

In order to be eligible, the registrants will generally be required to demonstrate that they hold qualifications, other than a prescribed qualification for general registration, relevant to their chosen area of special purpose practice, such as a tertiary level or professional qualifications in teaching and learning, research degrees or demonstrate that they are working towards one such as being registered for a PhD.

Council will need to be satisfied that the registrant is applying their professional knowledge in a non-clinical setting for at least 60% of the working week. For example, a letter from an employer that the registrant has a 0.6 FTE appointment for the period that an APC is being sought will generally be required and a statutory declaration that clinical practice is limited to 10 hours or less per week.

5. Scope of Practice: Trainee Osteopath

Registered trainee osteopaths are primary healthcare practitioners who are enrolled in the prescribed qualification for the General Osteopathic Scope of Practice (the Unitec Institute of Technology Master of Osteopathy course or an overseas course deemed by Council to be substantively the equivalent in order to permit student electives).

The trainee osteopath will have submitted the final draft of the thesis for the purpose of marking. All other components of the required course will be completed to a satisfactory level. The council sees that this final marking stage of the thesis, and the time that this takes, should not prevent practice of the student. The student will need to be working within a group practice to ensure peer support and is required to practise within the General Osteopathic Scope of Practice and comply with all related codes and practice standards.

The period of time that a trainee osteopath can practise under this scope of practice will normally be limited to six months, but may be extended at Council's discretion.

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Scope of Practice – Trainee Osteopath.

All applicants must:

- (1) be enrolled in the Unitec Institute of Technology Master of Osteopathy course;
- and

- (2) have successfully completed the following units in that course of study:

HEAL 8302 Clinical Science 1
HEAL 8303 Clinical Science 2
HEAL 8306 Clinical Practicum 1
HEAL 8308 Patient Management & Clinical Reasoning 1
HEAL 8305 Integrated Osteopathic Practice
HEAL 8307 Clinical Practicum 2
HEAL 8309 Patient Management & Clinical Reasoning 2
HEAL 8310 Professional Practice;

and

- (3) have submitted the research thesis component in that course of study.

6. Visiting Osteopathic Presenter / Educator Scope of Practice

The purpose of the Visiting Osteopathic Presenter / Educator Scope of Practice is to create a mechanism to allow overseas registered osteopaths to visit New Zealand for the purpose of presenting or teaching osteopathy without requiring full registration in the General Osteopathic Scope of practice. This will restrict the activities of the osteopath to the presenting and / or educating activities described in the application. Registration will in general be for the period of time required to deliver a specific course / training event.

Council may grant registration for an extended period if the candidate's application is supported by Unitec, another tertiary institute or the individual is otherwise eligible for registration in the General Osteopathic Scope of Practice, such as osteopaths registered in Australia.

Pursuant to section 12 of the Act, the Council has prescribed the following qualifications for registration in the Scope of Practice: Visiting Osteopathic Presenter / Educator.

All applicants must:

- (1) be registered, and in good standing, with an overseas healthcare regulatory authority (where such arrangements are in place) and possess an osteopathic qualification;
- and
- (2) be able to provide evidence of achievements in research / scholarship or teaching either by publication or educational attainments deemed by Council to be relevant to the osteopathic scopes of practice;
- and
- (3) submit an outline of the course / teaching activity they aim to deliver in New Zealand.
