 - The movement of the things listed in Schedule 1 below from any part of the controlled area to any part of New Zealand not in the controlled area, other than the North Island, is prohibited, except with the permission of an inspector or authorised person appointed under the Biosecurity Act 1993.
 - The movement of the thing listed in Schedule 2 into the buffer zone, from any part of the remaining controlled area, is prohibited, except with the permission of an inspector or authorised person appointed under the Biosecurity Act 1993.

Schedule 1

Things Subject to Movement Control in the Controlled Area

- Honey bees (meaning *Apis mellifera*), at any stage of development, including live beehives, nucleus colonies, frames of bee brood, queen bees and escorts, package bees and bulk bees.
- Used beehives (meaning anything that is being or has been used for the keeping of honey bees), including any part of any used beehive.
- Unused beehives containing wax foundation.
- Unprocessed beeswax, propolis and pollen, and any honey that is not packaged for retail sale.
- Used beekeeping equipment (excluding protective clothing, smokers, and hive tools).
- Any thing upon which, or within which, the varroa mite is present.

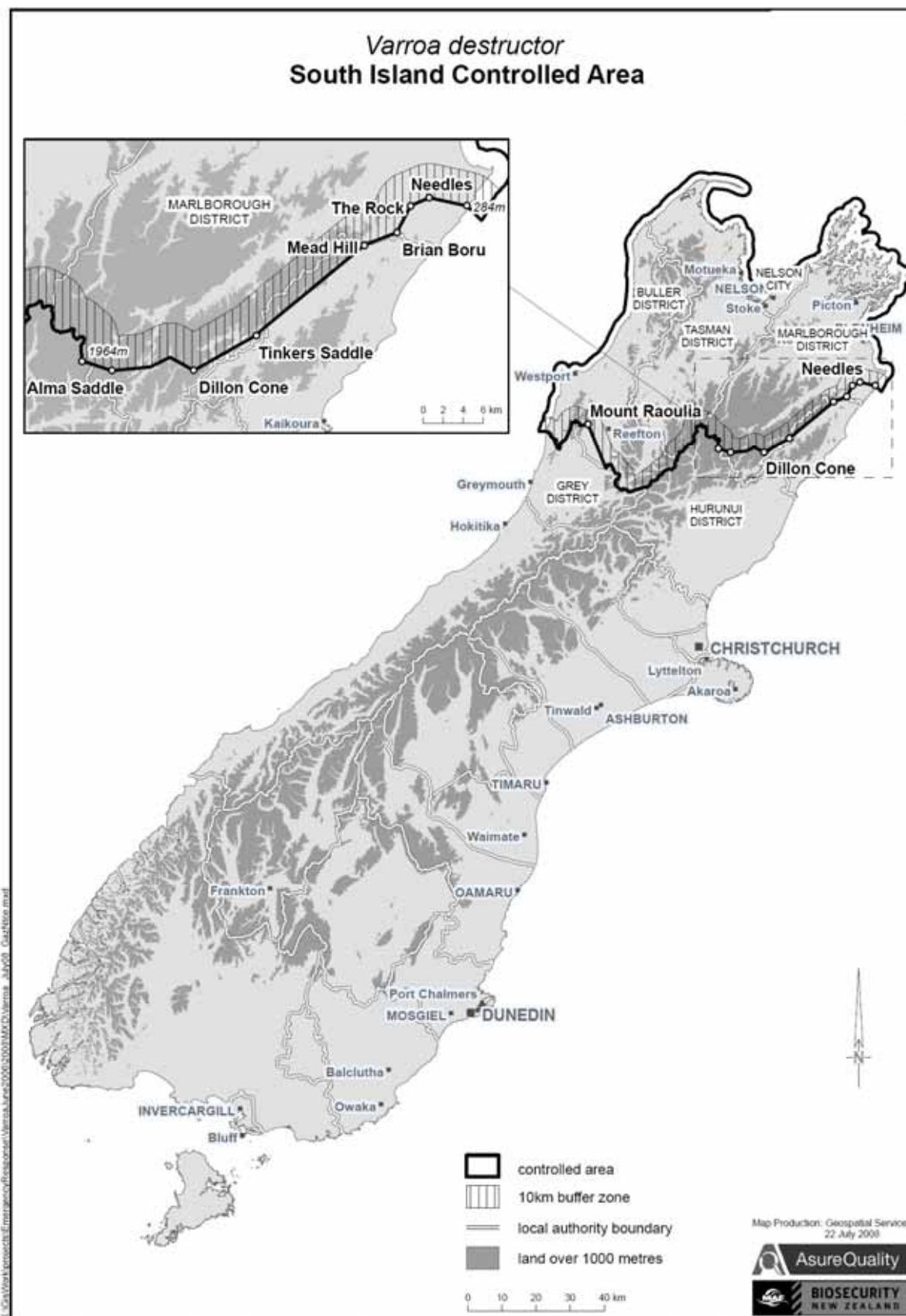

Dumping and Countervailing Duties Act 1988

Anti-dumping Duties: Notice That Anti-dumping Duties on Canned Peaches From Greece May Cease to Apply

Under section 14(9) of the Dumping and Countervailing Duties Act 1988 ("the Act"), anti-dumping duties imposed on canned peaches (halves, slices and pieces) packed in retail sized cans* from Greece will cease to apply to those goods on 15 December 2008 unless, at that date, the goods are subject to review under section 14(8) of the Act.

Positive evidence justifying the need for a review would need to include reasons for believing that the expiry of anti-dumping duties would be likely to lead to the continuation or recurrence of dumping of canned peaches from Greece and of material injury to the New Zealand industry producing canned peaches.

The reasons should be supported by evidence and not based on mere allegations or assertions.

Radiocommunications Regulations 2001

Radiocommunications Regulations (General User Radio Licence for Ultra Wide Band Communication Devices) Notice 2008

Pursuant to Regulation 9 of the Radiocommunications Regulations 2001 ("the Regulations") made under section 116(1)(b) of the Radiocommunications Act 1989 ("the Act"), and acting under delegated authority from the chief executive, I give the following notice.

Notice

1. Title, commencement and purpose—(1) This notice is the Radiocommunications Regulations (General User Radio Licence for Ultra Wide Band Communication Devices) Notice 2008.

(2) This notice comes into force on 1 September 2008.

2. General user radio licence—A general user radio licence is granted for the right to transmit radio waves for the purpose of ultra wide band (UWB) communications, in accordance with the terms, conditions and restrictions of this notice.

3. Terms, conditions and restrictions—(1) The ranges of frequencies specified and maximum power of transmissions permitted pursuant to this licence are those prescribed in the Schedule to this notice.

(2) Transmissions are not permitted:

- (a) onboard any aircraft; or
- (b) from any fixed outdoor transmitter or antenna.

(3) Transmitters must conform to technical standards as prescribed in notices under Regulation 32(1)(b) of the Regulations.

(4) Frequency use is on a shared basis and the chief executive does not accept liability under any circumstances for any loss or damage of any kind occasioned by use of this licence, including the unavailability of frequencies or interference to reception.

(5) Should interference occur to services licensed pursuant to a radio licence or a spectrum licence, the chief executive reserves the right to require and ensure that any transmission pursuant to this General User Radio Licence change frequency, reduce power or cease operation.

(6) A person authorised by the chief executive, shall be granted at all reasonable times entry to any premises, building, aircraft, ship, carriage, vehicle, box or receptacle for the purposes of ensuring compliance with this licence.

(7) Words and expressions defined in:

- (a) The Radiocommunications Act 1989, and Regulations and notices made under that Act; and
- (b) The International Radio Regulations annexed to the International Telecommunications Convention

- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.
