#### Biosecurity Act 1993

---

#### Biosecurity (Process for Establishing Independent Review Panel) Notice 2008

Pursuant to section 22A of the Biosecurity Act 1993, the Director-General of Agriculture and Forestry gives the following notice.

#### Notice

1. **Title**—This notice is the Biosecurity (Process for Establishing Independent Review Panel) Notice 2008.
2. **Commencement**—This notice comes into force on the day after the date of its notification in the *New Zealand Gazette*.
3. **Purpose**—The purpose of this notice is to set out the process by which an independent review panel is to be established to review whether, in developing an import health standard, there has been sufficient regard to the scientific evidence about which a person consulted under section 22(6) of the Biosecurity Act 1993 has raised a significant concern.

4. **Interpretation**—In this notice, unless the context otherwise requires:

**Act** means the Biosecurity Act 1993;

**chief technical officer** means a person appointed a chief technical officer under section 101 of the Act;

**director-general** means the Director-General of the Ministry of Agriculture and Forestry;

**import health standard** includes an amendment to an import health standard;

**independent review panel** means an independent review panel appointed under clause 11; and

**request** means a request made under clause 6.

5. **Establishment of an independent review panel**—

(1) The director-general may establish an independent review panel for the purposes of section 22A of the Act as a result of accepting a request.

(2) An independent review panel may be established:

- (a) after a chief technical officer has completed his or her consultation under section 22(6) of the Act, but before making his or her recommendation to the director-general; or
- (b) after a chief technical officer has made his or her recommendation, but before the director-general issues the import health standard concerned.

**6. Request for review**—(1) A person consulted under section 22(6) of the Act may request the establishment of an independent review panel to review whether, in developing an import health standard, a chief technical officer has had sufficient regard to the scientific evidence, if:

- (a) the person raised a significant concern about the scientific evidence when consulted under section 22(6) of the Act; and
- (b) the person notifies the director-general of his or her intention to request a review under clause 7(2).

(2) A request may be made following consultation on:

- (a) the risk analysis associated with a proposed import health standard; or
- (b) the proposed import health standard.

(3) A request must be made in writing to the director-general and must:

- (a) identify the part of the person's submission that explains the person's significant concern with the chief technical officer's consideration of the scientific evidence;
- (b) explain why the person considers that there has been insufficient regard to the scientific evidence; and
- (c) include any additional scientific information related to the concern that was not provided to the chief technical officer during consultation.

**7. Timing of request**—(1) The director-general must give a provisional version of the import health standard to persons consulted under section 22(6) of the Act after consultation on the proposed import health standard has been completed.

(2) A person who intends to request a review must notify the director-general in writing of the person's intention to make a request no later than 10 working days after the director-general gives the provisional version of the import health standard to the person.

(3) A person who notifies his or her intention to request a review in accordance with subclause (2) may make a request no later than 20 working days after the director-general gives a provisional version of the import health standard to the person.

**8. Extension of time**—(1) A person who intends to request a review may ask the director-general for an extension of the time for making a request at the same time as the person notifies his or her intention to make a request under clause 7(2).

(2) The director-general may waive or extend any time period specified in this notice if he or she considers that it is reasonable to do so in the circumstances.

**9. Decision on request for review**—(1) In considering whether to accept a request for review, the director-general must take into account:

- (a) the extent to which the scientific evidence is or may be material to the measures in the proposed import health standard;
- (b) the extent to which the request for review appears to be based on credible scientific evidence;
- (c) whether the evidence has been the subject of an earlier review; and
- (d) any other relevant matter.

(2) If the director-general accepts a request following consultation on the risk analysis associated with a proposed import health standard, he or she need not appoint an independent review panel until after consultation on the proposed import health standard has been completed.

(3) If the director-general accepts more than one request for review in relation to an import health standard, he or she may treat the requests that are accepted as one request.

(4) If the director-general refuses a request for review, he or she must give the reasons for the refusal to the persons consulted under section 22(6) of the Act.

**10. Director-general to ask for nominations for panel**

—(1) The director-general must ask persons consulted under section 22(6) of the Act to nominate persons to be appointed to an independent review panel.

(2) The director-general must have regard to any nominations received, but need not appoint a person nominated under subclause (1).

**11. Appointment of independent review panel**—(1) If the director-general decides to appoint an independent review panel, he or she may appoint one or more persons up to a maximum of five to be the panel.

(2) The director-general must appoint one member of the panel as chair.

(3) In appointing persons to a panel, the director-general must have regard to the need for the panel collectively to have the knowledge, skill, and experience relevant to:

- (a) the area of science that is the subject of the review;
- (b) risk analysis; and
- (c) the conduct of a review.

(4) The director-general may appoint to the panel a person who has knowledge, skill, or experience in an area other than those listed in subclause (3), if the director-general considers that the person's expertise would assist the panel in the review.

**12. Terms of reference**—(1) The director-general must set terms of reference for an independent review panel's conduct of a review.

(2) Before finalising the terms of reference, the director-general must give a draft of the terms of reference to persons consulted under section 22(6) of the Act for comment.

(3) The persons must send any comments on the draft of the terms of reference to the director-general no later than the date specified by the director-general.

(4) Terms of reference may specify:

- (a) the scope of the review;
- (b) questions to be addressed;
- (c) a timetable for the review and report to the director-general; and
- (d) any other matter the director-general considers appropriate.

**13. Information and assistance to be provided to independent review panel**—(1) The director-general must provide to an independent review panel:

- (a) the request for review;
- (b) the submissions of those consulted under section 22(6) of the Act to the extent that the submissions are relevant; and
- (c) all other relevant information held by the director-general.

(2) The director-general must provide administrative support to the panel.

**14. Conduct of review**—(1) An independent review panel must comply with the terms of reference set by the director-general under clause 12.

(2) The members of the panel may meet with each other in person or communicate by telephone or any other means



that allows the panel to fulfil its function effectively and efficiently.

(3) The panel may seek advice or information relevant to the review from any person.

(4) The panel must consider:

- (a) the request for review;
- (b) the submissions of all those consulted under section 22(6) of the Act and any summary of submissions prepared by the director-general to the extent that the submissions or the summary is relevant;
- (c) other relevant information provided by the director-general; and
- (d) all relevant new information received under subclause (3).

(5) Subject to this clause, a panel may regulate its own procedure.

**15. Reporting**—(1) An independent review panel must report its findings and recommendations to the director-general as soon as is reasonably practical but no later than the date set in the terms of reference.

(2) The director-general may allow the panel to report by a later date than that set in the terms of reference.

(3) The report must be in writing and:

- (a) include reasons for the panel's findings and recommendations;
- (b) indicate whether the recommendations are unanimous or agreed to by a majority of the panel; and
- (c) identify any person who advised the panel and state the nature of his or her advice.

**16. Publication of report**—The director-general must give a copy of the independent review panel's report to the person who requested the review and make copies available to the public on request.

### **Marine Mammals Protection Act 1978**

#### **Notice of Intention to Declare Four Marine Mammal Sanctuaries**

I give notice that I intend (with the consent of the Minister of Energy, the Minister of Fisheries, and the Minister of Transport) to declare, pursuant to section 22 of the Marine Mammals Protection Act 1978, four marine mammal sanctuaries, as follows:

- (a) A sanctuary, to be called the West Coast North Island Marine Mammal Sanctuary, comprising all the areas of the sea enclosed:
  - (i) on the landward side by the line of mean high water springs extending alongshore in a north-south direction from a point on Maunganui Bluff (approximately 35°45.54'S and 173°33.30'E), to a point on Oakura Beach (approximately 39°07.08'S and 173°55.87'E); and
  - (ii) on the seaward side by a line on a bearing of 270° to a point where it intersects with the outer limit of the territorial sea from the point on Maunganui Bluff (approximately 35°45.54'S and 173°33.30'E), thence by a line on a

bearing of 270° to a point where it intersects with the outer limit of the territorial sea limit from the point on Oakura Beach (approximately 39°07.08'S and 173°55.87'E), and thence by a line joining the above-mentioned seaward points corresponding with the outer limits of the territorial sea;

including all the areas of the sea contained in the internal waters within the north-south extent of the area defined above between the point on Maunganui Bluff (approximately 35°45.54'S and 173°33.30'E), to the point on Oakura Beach (approximately 39°07.08'S and 173°55.87'E).

(b) A sanctuary, to be called the Clifford and Cloudy Bay Marine Mammal Sanctuary, comprising all the areas of the sea enclosed:

- (i) by the line of mean high water springs from a point on Cape Campbell (at approximately 41°43.54'S and 174°16.57'E) thence by a line running in an easterly direction to a point at sea (at approximately 41°43.54'S and 174°32.59'E), thence by a line running in a north-westerly direction to a point on West Head on the Tory Channel (at approximately 41°12.79'S and 174°18.93'E); and
- (ii) by the line of mean high water springs alongshore in a north-south direction between the point on West Head on the Tory Channel (at approximately 41°12.79'S and 174°18.93'E) to the point on Cape Campbell (at approximately 41°43.54'S and 174°16.57'E).

(c) A sanctuary, to be called the Catlins Coast Marine Mammal Sanctuary, comprising all the areas of the sea enclosed:

- (i) by the line of mean high water springs from a point on Three Brother's Point (at approximately 46°39.74'S and 169°12.28'E) by a line running in a southerly direction to a point at sea (at approximately 46°44.74'S and 169°12.28'E), thence by a line running in a westerly direction to a point at sea (at approximately 46°43.30'S and 168°31.09'E), thence by a line running in a northerly direction to a point marked by the line of mean high water springs on Bushy Point (at approximately 46°36.37'S and 168°31.09'E); and
- (ii) by the line of mean high water springs alongshore in an east-west direction between the point on Bushy Point (at approximately 46°36.37'S and 168°31.09'E) to the point on Three Brother's Point (at approximately 46°39.74'S and 169°12.28'E);

(d) A sanctuary, to be called the Te Waewae Bay Marine Mammal Sanctuary, comprising all the areas of sea enclosed within Te Waewae Bay:

- (i) by the line of mean high water springs from a point on Pahia Point (at approximately 46°19.31'S and 167°41.19'E) to a point marked by the line of mean high water springs on Sand Hill Point (at approximately 46°15.34'S and 167°19.08'E) on the seaward side constituting a total distance of approximately 16.1 nautical miles; and
- (ii) by a line joining the point on Pahia Point (at approximately 46°19.31'S and 167°41.19'E)

and the point on Sand Hill Point (at approximately 46°15.34'S and 167°19.08'E) along the line of mean high water springs on the landward side.

I intend to impose in respect of all the sanctuaries the restrictions on the carrying out of acoustic seismic surveys stated in Schedule 1.

I intend to impose the restriction on the carrying out of mining stated in Schedule 2, in respect of the part of the proposed West Coast North Island Marine Mammal Sanctuary described as all the areas of the sea enclosed:

- (a) on the landward side by the low-water line extending along the baseline of the territorial sea in a north-south direction from a point on Maunganui Bluff (at approximately 35°45.54'S and 173°33.30'E), to a point on Oakura Beach (at approximately 39°07.08'S and 173°55.87'E); and
- (b) on the seaward side by a line on a bearing of 270° to a distance of two nautical miles from the point on Maunganui Bluff (approximately 35°45.54'S and 173°33.30'E), thence by a line running in a south-easterly direction at two nautical miles parallel to the baseline of the territorial sea to a point at sea being the point of intersection with a line on a bearing of 258° from Te Waha Point (at approximately 36°56.10'S and 174°27.21'E), thence to a point at sea at a distance of four nautical miles along that same line from Te Waha Point, thence by a line running in a south-easterly direction parallel to the baseline of the territorial sea to a point at sea at a distance of four nautical miles and at the point of intersection with the line on a bearing of 255° from Raupuke Beach Road (at approximately 37°54.28'S and 174°46.27'E), thence along that same line to a point at sea two nautical miles from the point on Raupuke Beach Road, thence by a line in a south-easterly direction continuing at a distance of two nautical miles parallel to the baseline of the territorial sea to a point at a distance of two nautical miles by a line on a bearing of 270° from the point on Oakura Beach (approximately 39°07.08'S and 173°55.87'E);

excluding all the areas of the sea contained in the internal waters within the north-south extent of the area defined above between the point on Maunganui Bluff (approximately 35°45.54'S and 173°33.30'E), to the point on Oakura Beach (approximately 39°07.08'S and 173°55.87'E).

**Schedule 1*****Restrictions on the Carrying out of Acoustic Seismic Surveys***

(1) No person may carry out an acoustic seismic survey from a vessel in the sanctuary unless he or she has, at least one month before doing so:

- (a) notified the Head Office of the Department of Conservation in Wellington in writing of his or her intention to carry it out; and
- (b) given the director-general a written undertaking, in a form satisfactory to the director-general, to give the director-general, within two months of the completion of the survey, a written report on all interactions between cetaceans and:
  - (i) the vessel or vessels used; or
  - (ii) any equipment on or operated from the vessel or vessels used; or
  - (iii) any person on the vessel or vessels used.

(2) No person may carry out from a vessel in the sanctuary an acoustic seismic survey using vibrations caused by explosions.

(3) No person may cause an acoustic seismic survey to be carried out from a vessel in the sanctuary unless the person ensures that, while the vessel is in the sanctuary for the purpose of carrying out the survey, all the following requirements are complied with on the vessel:

***Trained observers***

- (a) At all times, there must be on board at least two observers trained and experienced in whale and dolphin identification and behaviour, passive acoustic monitoring techniques, and distance estimation.
- (b) At all times during daylight hours while the survey is being carried out, at least one qualified observer must maintain a watch for cetaceans.

***Pre-start procedures***

- (c) For at least the 30 minutes before an acoustic source is activated or reactivated during daylight hours, at least one qualified observer must continuously make visual observations all around the vessel and source for the presence of cetaceans:
  - (i) from the bridge, or preferably an even higher vantage point; and
  - (ii) using both binoculars and the naked eye.
- (d) For at least the 30 minutes before an acoustic source is activated or reactivated during poor visibility, passive acoustic monitoring for the presence of cetaceans must be carried out by at least one qualified observer.

***Use of mitigating acoustic sources***

- (e) While no acoustic source is being used for data acquisition (for example, during manoeuvring of the vessel), a low-level mitigating acoustic source must be running.

***Activating acoustic source***

- (f) No acoustic source may be activated or reactivated if a cow-calf pair of cetaceans can be seen within 1,500m of the vessel or source.
- (g) No acoustic source may be activated or reactivated at any time if a cetacean has been seen within 500m of the vessel or source, or detected (at any distance) by passive acoustic monitoring, during the previous 30 minutes.

(h) No acoustic source may be activated or reactivated at any time during poor visibility if, during the previous 24 hours, three or more situations have arisen that either:

- (i) required an acoustic source to be turned off under any of paragraphs (l) to (n); or
  - (ii) but for the fact that no acoustic source was running, would have required an acoustic source to be turned off under any of those paragraphs.
- (i) No acoustic source may be activated or reactivated at any time during poor visibility if:
- (i) no acoustic source on the vessel has been active during the previous 24 hours; or
  - (ii) during the previous two hours, cetaceans have been seen from the vessel (or a spotter vessel or aircraft acting on the person's behalf) within 10,000m of the place where the source is.
- (j) An acoustic source must not be activated or reactivated except by gradually increasing power over a period of at least 30 minutes.
- (k) While an acoustic source is being activated or reactivated (otherwise than during poor visibility), at least one qualified observer must continuously make visual observations all around the vessel and source for the presence of cetaceans:
- (i) from the bridge, or preferably an even higher vantage point; and
  - (ii) using both binoculars and the naked eye.

***Requirements to shut down***

- (l) If, while an acoustic source is activated, a cow-calf pair of cetaceans is seen to be or come within 1,500m of the vessel or source, the source must immediately be shut down.
- (m) If, while an acoustic source is activated, a cetacean is seen to be or come within 500m of the vessel or source, the source must immediately be shut down.
- (n) If a cetacean is detected (at any distance from the vessel) by passive acoustic monitoring while an acoustic source is activated during poor visibility, the source must immediately be shut down.

***Operations during poor visibility***

- (o) While an acoustic source is being activated or reactivated during poor visibility, passive acoustic monitoring for the presence of cetaceans must be continuously maintained on the vessel.

(4) Paragraphs (c) and (d) of subclause (3) are cumulative.

(5) Paragraph (e) of subclause (3) does not limit or affect paragraphs (l) to (n) of that subclause.

**Schedule 2*****Restriction on Mining***

(1) No person may carry out mining in the part of the sanctuary subject to mining restrictions unless it is:

- (a) mining for petroleum; or
- (b) a minimum impact activity.

(2) Subclause (1) does not affect operations carried out under section 57 of the Crown Minerals Act 1991.

  - (ii) on the seaward side by a line on a bearing of 122° to a point where it intersects with the outer limit of the territorial sea from the northern bank of the mouth of the Waipara River (at approximately 43°09.43'S and 172°47.67'E), thence by a line on a bearing of 155° to a point where it intersects with the outer limit of the territorial sea from the southern bank of the mouth of the Rakaia River (at approximately 43°54.22'S and 172°11.69'E), and thence by a line joining the above-mentioned seaward points corresponding with the outer limits of the territorial sea;

including all the areas of the sea contained in the internal waters (other than lagoons and Lake Ellesmere) within the north-south extent of the sanctuary between the northern bank of the mouth of the Waipara River (at approximately 43°09.43'S and 172°47.67'E), to the southern bank of the mouth of the Rakaia River (at approximately 43°54.22'S and 172°11.69'E).

- (b) impose on the redefined sanctuary the restrictions stated in the Schedule of this notice.

  - (ii) any equipment on or operated from the vessel or vessels used; or
  - (iii) any person on the vessel or vessels used.
- (2) No person may carry out from a vessel in the sanctuary an acoustic seismic survey using vibrations caused by explosions.
- (3) No person may cause an acoustic seismic survey to be carried out from a vessel in the sanctuary unless the person ensures that, while the vessel is in the sanctuary for the purpose of carrying out the survey, all the following requirements are complied with on the vessel:

#### *Trained observers*

- (a) At all times, there must be on board at least two observers trained and experienced in whale and dolphin identification and behaviour, passive acoustic monitoring techniques, and distance estimation.
- (b) At all times during daylight hours while the survey is being carried out, at least one qualified observer must maintain a watch for cetaceans.

#### *Pre-start procedures*

- (c) For at least the 30 minutes before an acoustic source is activated or reactivated during daylight hours, at least one qualified observer must continuously make visual observations all around the vessel and source for the presence of cetaceans:
  - (i) from the bridge, or preferably an even higher vantage point; and
  - (ii) using both binoculars and the naked eye.
- (d) For at least the 30 minutes before an acoustic source is activated or reactivated during poor visibility, passive acoustic monitoring for the presence of cetaceans must be carried out by at least one qualified observer.

#### *Use of mitigating acoustic sources*

- (e) While no acoustic source is being used for data acquisition (for example, during manoeuvring of the vessel), a low-level mitigating acoustic source must be running.

#### *Activating acoustic source*

- (f) No acoustic source may be activated or reactivated if a cow-calf pair of cetaceans can be seen within 1,500m of the vessel or source.

- (i) No acoustic source may be activated or reactivated at any time during poor visibility if:
  - (i) no acoustic source on the vessel has been active during the previous 24 hours; or
  - (ii) during the previous two hours, cetaceans have been seen from the vessel (or a spotter vessel or aircraft acting on the person's behalf) within 10,000m of the place where the source is.
- (j) An acoustic source must not be activated or reactivated except by gradually increasing power over a period of at least 30 minutes.
- (k) While an acoustic source is being activated or reactivated (otherwise than during poor visibility), at least one qualified observer must continuously make visual observations all around the vessel and source for the presence of cetaceans:
  - (i) from the bridge, or preferably an even higher vantage point; and
  - (ii) using both binoculars and the naked eye.

#### *Requirements to shut down*

- (l) If, while an acoustic source is activated, a cow-calf pair of cetaceans is seen to be or come within 1,500m of the vessel or source, the source must immediately be shut down.
- (m) If, while an acoustic source is activated, a cetacean is seen to be or come within 500m of the vessel or source, the source must immediately be shut down.

**Schedule 2**

**Other Proposed Conditions to be Attached to Student Achievement Component Funding Allocated and Paid for by the Tertiary Education Commission to Tertiary Education Organisations**

*General*

- These conditions apply to fees and course costs for all provider types: tertiary education institutions (TEIs), private training establishments (PTEs) and other tertiary education providers (OTEPs).
- As in 2008, fees for all courses that are above the fee and course costs maxima in 2009 should not increase above 2008 levels, but are not required to reduce to the relevant maximum.
- The fee and course costs in relation to a particular course of study or training will be subject to these conditions if:
  - the tertiary education organisation is the sole source of the item to which the cost relates;

- (b) all students enrolled in the relevant course of study or training are required to pay the fee or course costs; and
  - (c) the charge meets the guidelines for borrowing under the compulsory fees component of the student loan scheme.
4. The following items are included in the maxima: tuition fees, compulsory charges, and examination fees associated with a programme of study. The TEC may also specify additional items to be included in the maxima over and above those listed in this condition.

*Annual Fee Movement Limit (AFML)*

- 5. Fee movements in 2009 at a course level are limited to 5 percent for certificate, diploma and degree courses that receive student achievement component funding.
- 6. If the application of the annual fee movement limit (AFML) on fee and course costs results in an increase above the relevant maxima in 2009, then the provider can only increase up to the level of the maxima.

*Low or Zero Fee Courses*

- 7. If the fee and course costs for a course are less than \$444.44 (GST excl.) per Equivalent Full-Time Student (EFTS) in 2008, then for 2009, the provider can increase the fee to up to \$444.44 (GST excl.) per EFTS, or can increase the fee for the course by 5 percent, whichever is the greater.

*Postgraduate Qualifications and Courses*

- 8. Postgraduate courses are excluded from the fee and course costs maxima.
- 9. Postgraduate fee and course costs can be increased by \$444.44 (GST exclusive) per EFTS in 2009.
- 10. Professional masters programmes (eg MBAs) are exempt from the postgraduate fee increase limit, and are not subject to any limit on fee increases.

*Exemptions for Exceptional Circumstances*

- 11. Only TEIs may apply, on the basis of exceptional circumstances, for exemptions in 2009 from the AFML of 5 percent, for up to an additional 5 percent increase. An AFML exemption may allow fees to increase over the relevant fee and course costs maxima. In subsequent years, these fees will be subject to the policy for fees over the maxima.
- 12. TEIs and PTEs may apply, on the basis of exceptional circumstances, for exemptions in 2009 to the limit on postgraduate fee increases.
- 13. In considering "exceptional circumstances" exemptions, the TEC will use the following criteria:
  - (a) The organisation is unable to support the course(s) from its net financial surplus while remaining financially viable; and
  - (b) not increasing fees and course costs would compromise progress towards the achievement of the Tertiary Education Strategy 2007/12, the Statement of Tertiary Education Priorities 2008/10, or other critical elements of the tertiary reforms.
- 14. An application must satisfy both criteria to gain an exemption.

*Sanctions*

- 15. Where the TEC finds that a tertiary education provider is not complying with the conditions set out in this notice, it can withdraw student achievement component funding for that course. This sanction will only be exercised as a final resort, and the TEC will work with the provider to rectify any non-compliance in the first instance.

***Note: Effect of this Notice***

*These notes do not form part of this notice, but are intended to indicate its general effect.*

- A. Section 159L(3)(d) of the Education Act 1989 ("the Act") provides that the Minister, when determining the design of a funding mechanism, may specify the conditions that the TEC must attach to funding provided under the mechanism, including conditions that limit the fees that an organisation may charge domestic students.
- B. Under section 159M(b) of the Act, the Minister may not specify conditions setting limits on fees until two months after the date of publication of a notice in the *New Zealand Gazette* that:
  - (i) states that the Minister proposes to specify such conditions; and
  - (ii) sets out the proposed conditions; and
  - (iii) invites submissions on the proposed conditions; and
  - (iv) specifies the date by which submissions must be received, which must be a date no more than 21 days after the date of the *New Zealand Gazette* notice.
- C. The conditions setting limits on fees subsequently specified by the Minister in accordance with section 159L(3)(d) of the Act must be attached as conditions on the use of funding payable by the Tertiary Education Commission to an organisation under section 159YA and 159ZC of the Act.
- D. Under sections 227(1A) and 236C of the Act, TEIs and PTEs respectively must not charge domestic students a fee which exceeds the maximum specified as a condition on funding approved by the TEC under section 159YA and section 159ZC of the Act.

### Notice

1. **Title and commencement**—(1) This notice may be cited as the Fisheries (Kaimoana Customary Fishing) Notice (No. 7) 2008.

(2) This notice shall come into effect the day after the date of its notification in the *New Zealand Gazette*.

then generally south-westerly for 24 nautical miles to the point of commencement. The geographical coordinates named are in terms of the WGS84 datum.

3. **Request to cancel appointments**—The Tauranga Moana Iwi Customary Fisheries Working Committee, on behalf of Ngāiterangi, Ngāti Ranginui and Ngāti Pūkenga, being the tangata whenua who nominated Paul Borrell, William Te Arihi, Rewa Toma and the late Martin Tuhakaraina as Tangata Kaitiaki for the area/rohe moana, has requested in writing the cancellation of their appointments as Tangata Kaitiaki.

#### **Notice**

1. **Title**—(1) This notice is the Advice Notice to General Practitioners Concerning Patient Benefits and Other Subsidies (Amendment No. 8).

(2) In this notice, the Advice Notice to General Practitioners Concerning Patient Benefits and Other Subsidies<sup>1</sup> is called the “principal notice”.

2. **Commencement**—This notice comes into force on 1 July 2008.

#### **“3A Meningococcal B immunisation**

3A.1 From 1 June 2008 the meningococcal B vaccine programme will be stopped. Babies will no longer routinely be offered MeNZB™ vaccine.

3A.2 A child may complete a course of MeNZB™ vaccine. Parents and children should be encouraged to complete the course before 31 December 2008, although the vaccine will still be available after that date.

3A.3 If a parent of a child or young person up to 19 years of age requests that the child receives a course of MeNZB™ vaccine, and the general practitioner agrees, the MeNZB™ vaccine is available and funded. A general practitioner may start the child’s course of MeNZB™ without further authorisation and the Immunisation Benefit may be claimed.

3A.4 The MeNZB™ vaccine will still be available for individuals of any age with a high risk of invasive meningococcal infection and specific conditions (included in the Immunisation Handbook and amendments notified by the Ministry of Health).

3A.5 Primary Health Organisations and general practitioners shall administer a course of three MeNZB™ doses and a fourth MeNZB™ dose for eligible children who received the 1st dose of MeNZB™ under six months of age, or as otherwise advised by the Ministry of Health.

3A.6 MeNZB™ vaccine will be supplied and distributed through the Ministry of Health’s nominated vaccine distributor at no cost to immunisation providers.”

(c) Clause 4.6 is amended by omitting “\$17.43” and substituting “\$17.92” in both places where it occurs.

(d) Clause 5.5 is amended by omitting “\$17.43” and substituting “\$17.92”.

(e) Clause 5.7 is amended by omitting “\$17.43” and substituting “\$17.92”.

(f) Clause 5.8 is amended by omitting “\$17.43” and substituting “\$17.92”.

4. **Statement of reasons for departure from terms and conditions of the principal notice for purposes of section 89(5) of the New Zealand Public Health and Disability Act 2000**—The terms and conditions in this notice depart from the terms and conditions in the principal notice for the following reasons:

(a) To increase the subsidised fee for immunisations by 2.8%;

(b) to update some terms and conditions of the principal notice

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits,

protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions—**  
(1) The Public Trust Common Fund Interest Rates Notice 12 June 2008 is revoked.

- (c) extending the exemption will allow time for the recommendation of the variable reserves rule change proposal which has been delayed because of the delay to the system operator’s software upgrade.
