The Public Trust Common Fund Interest Rates Notice 27 March 2008

The following notice is given pursuant to section 50 of the Public Trust Act 2001 ("the Act").

Notice

1. Title and commencement—(1) This notice may be cited as the Public Trust Common Fund Interest Rates Notice 27 March 2008.

(2) The determinations and revocation in this notice take effect from and including 19 March 2008.

2. Interpretation—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

“call deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

“deposit” means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“protection deposit” means a deposit, held at call, of tuition, boarding, accommodation or other fees by or on behalf of a student enrolled at a private training establishment within the meaning of Part 18 of the Education Act 1989;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit (not being an agency deposit, an investment deposit, a protection deposit or a special deposit) held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call.

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest on deposits (other than investment deposits repayable at the end of fixed term or protection deposits) shall be that specified in Schedule 1 for the appropriate type of deposits.

(2) The rate of Common Fund interest on each protection deposit associated with a particular private training establishment shall be that specified in Schedule 2 for the appropriate dollar range of the total of those deposits.

(3) The rate of Common Fund interest payable on investment deposits repayable at the end of a fixed term shall be that specified in Schedule 3 for the appropriate interest payment frequency, term and dollar range.

(4) Despite subparagraph (1), the rate of Common Fund interest payable on deposits made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(5) Despite subparagraphs (1), (2) and (3), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on investment deposits, protection deposits or special deposits that is different from the rate specified in Schedules 1, 2, or 3 and the agreed rate then applies.

4. Revocation of notice and transitional provisions—

(1) The Public Trust Common Fund Interest Rates Notice 13 March 2008 is revoked.

(2) The rates of interest specified in Schedules 1 and 2 to this notice do not apply to any period that ends with 18 March 2008 but otherwise operate as from 19 March 2008.

(3) The rates of interest specified in Schedule 3 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 19 March 2008; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 19 March 2008.

Crown Entities Act 2004

Notice of Revocation and Replacement of Direction to the Foundation for Research, Science and Technology Pursuant to Section 103 of the Crown Entities Act 2004

Stable Funding

1. This direction comes into effect on 1 July 2008.
2. This direction replaces the previous direction, 4 May 2006, given to the Foundation for Research, Science and Technology made under section 103 of the Crown Entities Act 2004. This direction does not replace or revoke any direction made under the Foundation for Research, Science and Technology Act 1990 ("FRST Act"), including directions to allocate funds in accordance with a ministerial scheme or notice of priorities that the Foundation for Research, Science and Technology ("the foundation") must adhere to. Nor does it vary the Foundation's obligations under the FRST Act.

Purpose of the Direction

3. This direction instructs the foundation to:
 - (a) give effect to government policy to improve the effectiveness and stability of the Vote Research, Science and Technology funding environment;
 - (b) evaluate the implementation and effect of this direction with the Ministry of Research, Science and Technology.

Application of the Direction

4. This direction applies to all funds that are within the New Economy Research Fund, Research for Industry or Environmental Research output expenses, but does not apply to:
 - (a) Outcome-based Investments; or
 - (b) any funds covered by any ministerial scheme within either Research for Industry output expense or Environmental Research output expense.

Policy

5. This direction covers aspects of the Government's policy for a more effective and stable funding environment for science (CAB Min (06) 14/1 and CAB Min (07) 45/4 refers). This policy includes the Government's intent that the foundation implements specific negotiated funding processes to apply within the New Economy Research Fund, Research for Industry and Environmental Research output expenses ("the Negotiated Investment Process").

Direction

6. In pursuance of the policy referred to in paragraph 5, I direct the foundation, in its allocation of funds to which this direction applies, to ensure:
 - (a) there will be progressive implementation of the Negotiated Investment Process for eligible programmes within Vote Research, Science and Technology;
 - (b) that to be considered eligible for a Negotiated Investment Process, a research programme will have to:
 - (i) be of sufficient size;
 - (ii) demonstrate strategic relevance to Government and/or sector goals;
 - (iii) have undergone a technical review that demonstrates satisfactory performance; and

- (iv) have previously received funding from the foundation.
- (c) that research programmes eligible for the Negotiated Investment Process also satisfy quality and relevance criteria that include, but are not limited to, a combination of the following:
 - (i) scientific and technical quality, including track-record of delivering benefit to New Zealand; and future potential to deliver benefit to New Zealand;
 - (ii) long-term comparative advantage in an area of direct benefit to New Zealand, or unique significance to New Zealand;
 - (iii) alignment with relevant end-user and Government strategies;
 - (iv) evidence of end-user support and industry co-funding; and
 - (v) a track record of the research organisations' accountability for public money.
- (d) that Negotiated Investment Processes will be applied only in the following output expenses:
 - (i) New Economy Research Fund (with the total value of Negotiated Investment Process investments not to exceed 30% of this output expense);
 - (ii) Research for Industry (with the total value of Negotiated Investment Process investments not to exceed 40% in each of this output expense); and
 - (iii) Environmental Research (with the total value of Negotiated Investment Process investments not to exceed 40% in each of this output expense).

Outcome-based Investment and funds to which a ministerial scheme applies do not count toward the calculation of the percentage cap within the Research for Industry and Environmental Research output expenses, but do form part of the total relevant output expense.
- (e) there will be progressive implementation of technical review for all research programmes within Vote Research, Science and Technology to improve performance and develop a strong evidence base to inform future investment decisions.

7. I direct that, when allocating funds for the 2008/09 financial year onwards, the foundation consider, in accordance with the FRST Act, using a mix of processes that include but are not limited to the Negotiated Investment Process and contestable processes. The foundation will be the sole decision-maker regarding whether an investment is made via a contestable process, Negotiated Investment Process, or otherwise.

8. When determining the type of process to be used in allocating funds, I direct that the foundation pay particular attention to the government's desire that the allocation process achieve:
 - (a) more consistent delivery of longer-term research, science and technology outcomes to the private and public sector that benefit New Zealand;
 - (b) reduced transaction costs and complexity for research organisations;
 - (c) enduring linkages and collaboration between research organisations and the end-users of the research; and
 - (d) greater clarity for research organisations to plan and develop strategies for the longer-term.

9. I direct that the foundation monitors the implementation and effect of this direction at a time to be agreed by the foundation and the Ministry of Research, Science and

Technology. This evaluation will be a joint undertaking led by the Ministry of Research, Science and Technology.
The direction dated 4 May 2006 and published in the *New Zealand Gazette*, 18 May 2006, No. 47, page 1183, is revoked.

Electricity Governance Regulations 2003

Electricity Governance Regulations (Exemption No. 61 (Transpower New Zealand Limited)) Exemption Notice 2008

Pursuant to Regulation 194(2) of the Electricity Governance Regulations 2003, the Electricity Commission ("Commission") gives the following notice.

Notice

1. Title and commencement—(1) This notice is the Electricity Governance Regulations (Exemption No. 61 (Transpower New Zealand Limited)) Exemption Notice 2008.

(2) This notice comes into force on the day after the date it is notified in the *New Zealand Gazette*.

2. Exemption—Transpower New Zealand Limited, in its capacity as system operator ("system operator"), is exempted from compliance with the obligation to submit a draft policy statement, contained in Rule 10.1 of Section II of Part C of the Electricity Governance Rules 2003 (Rules).

3. Terms and conditions—This exemption is granted on the following conditions:

- (a) that it only applies to the draft policy statement required to be submitted by the system operator no later than 31 March 2008; and
- (b) that it will expire on 30 September 2008.

4. Reasons for granting the exemption—The reasons for granting this exemption are:

- (a) it would be unreasonable to require the system operator to submit a draft policy statement when no significant or substantial changes have been identified during the system operator's pre-consultation;
- (b) the policy statement review process prescribed by Rules 10 and 11 of Section II of Part C of the Rules is time and resource intensive for all affected parties and is not considered the best utilisation of resources if no substantive issues require effecting a new policy statement;
- (c) the exemption does not preclude the application of Rule 12.2 of Section II of Part C, which allows variations to the policy statement to be proposed to the board by any participant at any time; and
- (d) the outcome of the Commission's review in March 2007 of the policy statement review process showed a reasonable measure of industry support for a two-yearly policy statement review cycle. However, the annual review was retained largely at the request of the system operator, and noting the ability of the system operator to seek an exemption in circumstances such as these.

Education (Tertiary Reforms) Amendment Act 2007

Requirements and Exemptions for Plans (Investment Plans) for 2008–2010 for Tertiary Education Organisations Notice (No. 3) 2008

Pursuant to sections 159R, 159U and 159Y of the Education (Tertiary Reforms) Amendment Act 2007, the Tertiary Education Commission (TEC) gives the following notice.

Notice

1. Title—This notice may be cited as the Requirements and Exemptions for Plans (Investment Plans) for 2008–2010 for Tertiary Education Organisations Notice (No. 3) 2008.

2. Commencement—This notice applies from the date of its publication.

3. Application—From the date of its publication, this notice revokes and replaces two previously published notices relating to the requirements and exemptions for Profiles (Investment Plans) for 2008–2010. The notices revoked and replaced by this notice, as at the date of its publication, are:

- (a) *Requirements and Exemptions for Profiles (Investment Plans) for 2008–2010 for Tertiary Education Organisations* (published by the TEC*, pursuant to sections 159X and 159Y of the Education Act 1989); and

- (b) *Requirements and Exemptions for Profiles (Investment Plans) for 2008–2010 for Tertiary Education Organisations Notice (No. 2) 2007* (published by the TEC†, pursuant to sections 159X and 159Y of the Education Act 1989).

4. Introduction—Investment Plans may be approved by the TEC for funding for a period of up to three years.

5. Investment Plans will be summary-level documents. The scale of the Plans will vary, depending on the size and complexity of the organisation.

6. To access funding from the TEC for 2009 and onwards, all organisations, other than those exempted by paragraph 10 of this notice, are required to have an approved Investment Plan in place by 31 December 2008.

7. Content Criteria for Plans—Proposed Plans submitted to the TEC will be the output of collaboration between each organisation and the TEC. The proposed Plan will present a summary of the organisation's planning context, its three-year outlook and planned provision. The proposed Plan will also set out the key performance indicators to be used for monitoring progress and achievement.

8. The proposed Plan must include the following information (comprising four parts):

- (i) *Plan Context* (this section establishes the framework for the rest of the Plan)

Outline of the particular factors the organisation has considered and intends to respond to in its proposed Plan, including:

- Government priorities in the Tertiary Education Strategy 2007–12 (TES) including the distinctive contribution expected of the type of organisation;
- needs and priorities of students and other stakeholders; and

- areas for organisational capability development (including those for the delivery of quality education and research).

The organisation's role within the tertiary education system including:

- brief statements on the organisation's core purpose and local, regional, industry or national fit, including any shifts required to achieve these.

(ii) *Three-year Outlook*

Planned activity for the three-year period to address the factors identified in the *Plan Context* including:

- outcomes the organisation intends to achieve;
- initiatives, including capability development, that will be undertaken to achieve those outcomes;
- a description of other tertiary education programmes not funded by the TEC; and

any other key changes in core activities.

(iii) *Summary of Activity*

Information on delivery over the period of the proposed Plan including:

- Student Achievement Component (SAC) or Industry Training Fund student numbers by National Qualification Award Level (1–10);
- planned activities, programmes and student numbers for other TEC-funded activities and programmes;
- total TEC funding sought; and
- planned student numbers in more detail if requested by the TEC.

(iv) *Key Performance Indicators*

Measures to be used in evaluating performance against the proposed Plan, including:

- outcome commitments for the key performance indicators in relation to TES priorities and the key shifts expected of each type of organisation in the TES; and
- other organisational outcome commitments for initiatives and changes in the *Three-year Outlook*.

9. Decision-making Criteria—In reaching a decision about what to approve within the proposed Plan, including what to fund and the period of funding, the TEC will consider the following in relation to each tertiary organisation:†

- The organisation's planned alignment with the TES, including the distinctive contribution and key shifts expected of that type of organisation, and its contribution to the tertiary network of provision;
- evidence of effective identification of stakeholder needs and priorities;
- the organisation's governance and management arrangements, and financial viability;
- evidence of the organisation's capability in forecasting, planning and implementation;
- past performance against organisational commitments (including quality and capability improvement commitments);
- evidence of critical reflection on current performance;
- the allocation of SAC, TEO Component or other TEC funding, and other Government funding available to the organisation;

- whether the activities outlined in the proposed Plan are appropriate and achievable; and
- whether any conditions or limits on funding are required, having regard to appropriations, and any relevant and applicable funding determinations issued by the Minister under the Education Act 1989.

10. Exemptions—The following organisations are exempted from the requirement to prepare and submit a proposed Plan in 2008 for funding in 2009:

- Organisations that the TEC is contracting only pilot initiatives and who otherwise receive no other funding from the TEC;
- employers only receiving Workplace Literacy funding from the TEC;
- Government Training Establishments;
- community groups receiving Community Learning Aotearoa New Zealand (CLANZ) grants and who otherwise receive no other funding from the TEC; and
- organisations that only receive the English for Migrants pre-purchased English tuition fees from the TEC.

11. For the avoidance of doubt, organisations that already have an Investment Plan approved by the TEC in 2007 for funding in 2009 (ie an Investment Plan with more than one year's approval) will not be required to submit a proposed Plan in 2008.

12. Timelines and Processes—The TEC Investment Guidance to assist organisations in developing their proposed Plans is available on the TEC's website

www.tec.govt.nz

Further Supplementary Investment Guidance will be available from April 2008.

13. Funding Arrangements for 2008—The following organisations are exempt from the requirement to have an approved Investment Plan in place by 31 December 2007 for funding in 2008:

- Organisations that the TEC is contracting only pilot initiatives and who otherwise receive no other funding from the TEC;
- employers only receiving Workplace Literacy funding from the TEC;
- Government Training Establishments;
- schools;
- Rural Education Activities Programme providers (REAPs);
- community education providers; and
- Private Training Establishments (PTEs) that received less than \$2 million in TEC funding in 2006.
