Dumping and Countervailing Duties Act 1988

2007 Reassessment of Anti-dumping Duty: Canned Peaches from South Africa

Pursuant to section 14 of the Dumping and Countervailing Duties Act 1988 (“the Act”), the Minister of Commerce, having carried out a reassessment of the anti-dumping duty applying to imports into New Zealand of canned peaches from South Africa and having determined new amounts of anti-dumping duty applicable to those goods, gives the following notice.

Fisheries Act 1996

Fisheries (Seabird Sustainability Measures—Surface Longlines) Notice 2008 (No. F429)

Pursuant to section 11 of the Fisheries Act 1996, the Minister of Fisheries gives the following notice.

Notice

1. **Title**—This notice is the Fisheries (Seabird Sustainability Measures—Surface Longlines) Notice 2008.
2. **Commencement**—This notice comes into force the day after the date of its notification in the *New Zealand Gazette*.
3. **Interpretation**—In this notice, unless the context otherwise requires:
 - “Act” means the Fisheries Act 1996;
 - “nautical dawn” means the time at sunrise when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the place;
 - “nautical dusk” means the time at sunset when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the place;
 - “set”, in relation to a surface longline, means releasing the surface longline into the water;
 - “surface longline” means a line to which a hook or hooks (whether baited or not) are attached, and that is:
 - (a) suspended by floats; and
 - (b) not attached to the sea floor.
4. **Notification of use of surface longlines**—(1) No commercial fisher may use surface longlines to take tuna or swordfish within the exclusive economic zone of New Zealand without giving written notification to the chief executive of the intention to do so at least 5 days before doing so.
(2) The chief executive may exempt any particular commercial fisher from the requirement of subclause (1) if satisfied in the circumstances that the requirement is not necessary.
5. **Seabird scaring devices required if surface longlines used**—If a commercial fisher uses a surface longline to take fish, aquatic life or seaweed within the exclusive economic zone of New Zealand, the commercial fisher must:
 - (a) carry a seabird scaring device approved by the chief executive on board the vessel used by the commercial fisher; and
 - (b) use the seabird scaring device in accordance with the written requirements issued by the chief executive (if any); and
 - (c) permit inspection of the seabird scaring device on board the vessel used by the commercial fisher at any reasonable time by a fisheries officer or an observer appointed under section 223(2) of the Act.
6. **Restrictions on use of surface longlines**—No commercial fisher may set surface longlines to take fish, aquatic life or seaweed within the exclusive economic zone of New Zealand between the hours of 0.5 hours before nautical dawn and 0.5 hours after nautical dusk, unless line weighting is employed in accordance with clause 7 of this notice.
7. **Line weighting**—(1) For the purposes of clause 6, a metal weight of 45g or more must be attached for every hook deployed.
(2) The position of the weight must correspond to one of the following:
 - (a) Weights less than 60g must be within 1m of the hook; or
 - (b) weights of 60g–98g must be within 3.5m of the hook; or
 - (c) weights greater than 98g must be within 4m of the hook.
8. **Place of notification**—For the purposes of clause 4(1), a commercial fisher may notify the chief executive by delivering the notification:
 - (a) by hand to Observer Services, Ministry of Fisheries, Level 9, ASB Bank House, 101–103 The Terrace, Wellington; or
 - (b) by post to Observer Services, Ministry of Fisheries, PO Box 1020, Wellington; or
 - (c) by email to observer@fish.govt.nz; or
 - (d) by facsimile to (04) 819 4775.
9. **Revocation**—The Fisheries (Seabird Sustainability Measures) Notice 2007 (No. F393) (Supplement to *New Zealand Gazette*, 26 January 2007, No. 8, page 175) is revoked.

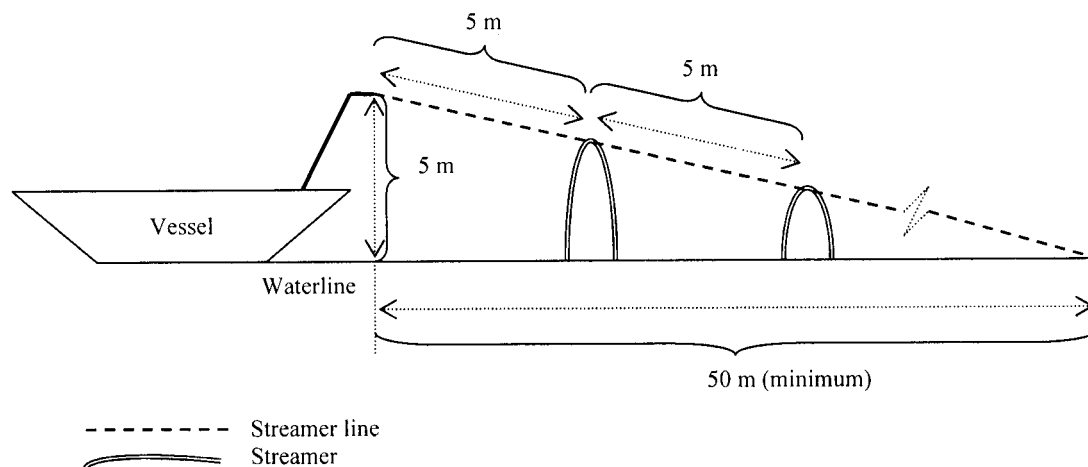

Fisheries (Seabird Sustainability Measures—Bottom Longlines) Notice 2008 (No. F430)

Pursuant to section 11 of the Fisheries Act 1996, the Minister of Fisheries gives the following notice.

Notice

- 1. Title**—This notice is the Fisheries (Seabird Sustainability Measures—Bottom Longlines) Notice 2008.
- 2. Commencement**—This notice comes into force 28 days after the date of its notification in the *New Zealand Gazette*.
- 3. Interpretation**—In this notice, unless the context otherwise requires:
 - “Act” means the Fisheries Act 1996;
 - “aerial extent” means the section of the streamer line backbone running from the vessel stern, to where the backbone of the streamer line enters the water;
 - “bottom longline” means a line to which 7 or more hooks (whether baited or not) are attached, and is sunk using weights also attached;
 - “hauling” means the period from when line retrieval commences to when the longline is completely onboard;
 - “nautical dawn” means the time at sunrise when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the location of fishing;
 - “nautical dusk” means the time at sunset when the centre of the sun is at a depression angle of 12 degrees below the ideal horizon for the location of fishing;
 - “offal” means solid fish parts, including heads, guts, frames, tails, tentacles and fish trimmings, or parts thereof including minced parts; and
 - “set”, in relation to a bottom longline, means releasing the bottom longline into the water.
- 4. Streamer line required**—A commercial fisher using bottom longlines as a method of fishing must:
 - (a) carry a streamer line on board the vessel used by the commercial fisher; and
 - (b) permit inspection of the streamer line at any reasonable time by a fisheries officer or an observer appointed under section 223(2) of the Act.
- 5. Use of streamer line during setting of bottom longlines**—During the setting of bottom longlines, the streamer line must be used in accordance with clause 6 of this notice.
- 6. Streamer line specifications**—(1) The streamer line must meet the following specifications:
 - (a) The streamer line must be attached to the vessel so that when deployed the baits are protected by the streamer line, even in cross wind;
 - (b) the streamer line must be a minimum of 150 metres in length;
 - (c) the streamer line must achieve a minimum aerial extent of 50 metres;
 - (d) streamers must be brightly coloured;
 - (e) streamers must be spaced at a maximum of 5 metres apart, beginning not more than 5 metres from the stern of the vessel and extending thereafter along the aerial extent of the line;
 - (f) when deployed, each of the streamers must reach the sea surface in the absence of wind and swell. Streamer length will therefore vary depending on the height of their attachment point above the water; and
 - (g) the streamer line must be suspended from a point on the vessel at least 5 metres above the water in the absence of swell.(2) The specifications in subclause (1) do not apply to additional or secondary seabird scaring devices fishers may choose to use (such as a second tori or streamer line).
- 7. Restrictions on use of bottom longlines**—No commercial fisher may set bottom longlines to take fish, aquatic life or seaweed between the hours of 0.5 hours before nautical dawn and 0.5 hours after nautical dusk, unless line weighting is employed in accordance with clause 8 of this notice.
- 8. Line weighting**—(1) For the purposes of clause 7, lines must be:
 - (a) an integrated weighted line with a lead core of at least 50g/m; or
 - (b) when externally weighted gear is used, attach at least 4 kilograms of metal weight for every 60 metres of line.(2) Regardless of the type of line weighting used under clause 8(1):
 - (a) any rope or line used to attach weights to the hook-bearing line must not be longer than 10 metres; and
 - (b) no more than 3 floats (up to 120 millimetres in diameter) may be attached to the hook-bearing line for every 60 metres of line, unless an additional 1 kilogram weight is added to the line per additional float; and
 - (c) floats greater than 120 millimetre in diameter are not permitted to the hook bearing line.
- 9. Restriction of offal or fish discharge while setting and hauling bottom longlines**—(1) No person may discharge offal or fish during setting of bottom longlines.
 - (2) Offal or fish may be discharged during the hauling of bottom longlines provided it is discharged from the side of the vessel that is opposite to side which the hauling station is located.
 - (3) Subclause (1) does not apply to:
 - (a) fish that are legally undersize; or
 - (b) fish that are listed on the Sixth Schedule of the Fisheries Act 1996 and that are likely to survive.
- 10. The Schedule**—(1) The Schedule provides further guidelines on the design and deployment of streamer lines as seabird scaring devices.
 - (2) The Schedule is not part of the specifications.
 - (3) If there is any inconsistency between the guidelines in the Schedule and the specifications, the specifications prevail.

- (i) The streamer line needs to protect baited hooks from seabirds. This means that the streamer line should be positioned in such a way that streamers are flapping in an unpredictable fashion, above the area in which the baited hooks enter the sea, so that seabirds are deterred from attempting to take bait from the hooks. In order to achieve this even during cross-winds, it is expected fishers will have to make adjustments to the configuration of the streamer line depending on the conditions.
- (ii) It is generally recognised as best practice to maximise the aerial extent of the streamer line, because this maximises the area in which the baited hooks are protected from seabirds. Best practice would be to achieve an aerial extent of 100 metres or more. In order to maximise aerial extent, it is necessary to create tension in the streamer line. This can be achieved by:
 - towing an object on the terminal end of the streamer line; or
 - towing extra length of streamer line; or
 - increasing the diameter of the in-water section of the streamer line.
- (iii) In order to be effective at scaring seabirds away from the line of baited hooks, the streamer lines should not become tangled, either with each other or with the branchline. Each streamer shall be attached to the streamer line in a manner to prevent fouling of individual streamers with the streamer line, and to ensure individual streamers reach the waterline in the absence of wind or swell. Swivels or a similar device can be placed in the streamer line in such a way as to prevent streamers being twisted around the streamer line. Each streamer may also have a swivel or other device at its attachment point to the streamer line to prevent fouling of individual streamers.
- (iv) Streamers are to be spaced at 5-metre intervals along the aerial extent of the line. The total number of streamers in use will vary depending on how the line is configured. Streamers that are hanging in the water can be prone to tangling. Because the far end of the streamer line will frequently be in the water, fishers may not wish to have streamers the whole way down the line. However, it is important that streamers are present to deter birds from taking baited hooks all along the part of the line that remains above water, as outlined in the specifications.
- (v) To ensure streamers are visible to birds, they should stand out against the surroundings. Streamers should be made of brightly coloured fluorescent plastic tubing or other material. Bright colours such as red, yellow, orange or pink are most effective during day setting. For night setting, the streamers should be of a colour that contrasts with the surroundings. Colours such as blue and green are less likely to be effective, because they are less likely to be highly visible to birds.
- (vi) A complete additional streamer line should be carried as a spare.

2. **Commencement**—This notice shall come into effect on 1 June 2008.
3. **Interpretation**—In this notice:

“hauling” means the period from when the winches are engaged to retrieve the trawl net from fishing depth:

- (a) to when the trawl net is completely onboard; or
- (b) when the trawl net is not brought completely onboard, to when shooting next occurs;

“offal” means solid fish parts, including heads, guts, frames, tails, tentacles and fish trimmings, or parts thereof including minced parts;

“shooting” means the period from when the trawl net is released from the vessel into the water, until the trawl doors and trawl net are fully submerged; and

“tow” means the period after shooting and before hauling, when the trawl net is fully submerged in the water.

4. Restriction of offal or fish discharge—(1) No person operating a vessel 28 metres or less in overall length for the purposes of trawling may discharge offal or fish:

- (a) on more than one occasion per tow; or
- (b) during shooting and hauling; or
- (c) within 20 minutes before shooting, unless the vessel has moved at least 1 nautical mile from the location of the last offal or fish discharge.

(2) Subclause (1) does not apply to:

- (a) fish that are legally undersize; or
- (b) fish that are listed on the Sixth Schedule of the Fisheries Act 1996 and that are likely to survive.

5. Chief executive may grant exemption from discharge restrictions—(1) The chief executive may, on application by any person, exempt a vessel from the requirement under clause 4, if the chief executive is satisfied that compliance with the requirements under clause 4 would be unsafe for the vessel.

(2) Before granting an exemption, the chief executive may require the person to supply any evidence to show that compliance with the requirements under clause 4 would be unsafe for the vessel.

(3) The chief executive may revoke an exemption granted under subclause (1).

3. Interpretation—In this notice:

“hauling” means the period from when the winches are engaged to retrieve the trawl net from fishing depth:

- (a) to when the trawl net is completely onboard; or
- (b) to when shooting next occurs, if the net is not brought completely onboard;

“Limited Processing Fishing Vessel Register” means the register held by the New Zealand Food Safety Authority under the Animal Products (Regulated Control Scheme—Limited Processing Fishing Vessels) Regulations 2001 and called the “Limited Processing Fishing Vessel Register”;

“offal” means solid fish parts, including heads, guts, frames, tails, tentacles and fish trimmings, or parts thereof including minced parts;

“Risk Management Programmes Register” means the register held by the New Zealand Food Safety Authority under the Animal Products Act 1999 and called the “Risk Management Programmes Register”

“shooting” means the period from when the trawl net is released from the vessel into the water, until the trawl doors and trawl net are fully submerged; and

“tow” means the period after shooting and before hauling, when the trawl net is fully submerged in the water.

4. Restriction of offal or fish discharge—(1) No person operating a vessel 28 metres or greater in overall length for the purposes of trawling may discharge offal or fish:

- (a) during shooting and hauling; or
- (b) within 20 minutes before shooting, unless the vessel has moved at least 1 nautical mile from the location of the last offal or fish discharge; or
- (c) on more than one occasion per tow, if the vessel is not registered on the Limited Processing Fishing Vessel Register or Risk Management Programmes Register; or
- (d) for a period no longer than 10 minutes at a time, and not again for at least 30 minutes after completion of the previous discharge, if registered on the Limited Processing Fishing Vessel Register or Risk Management Programmes Register.

(2) Subclause (1) does not apply to:

- (a) fish that are legally undersize; or
- (b) fish that are listed on the Sixth Schedule of the Fisheries Act 1996 and that are likely to survive.

5. Chief executive may grant exemption from discharge restrictions—(1) The chief executive may, on application by any person, exempt a vessel from the requirement under clause 4, if the chief executive is satisfied that compliance with the requirements under clause 4 would be unsafe for the vessel.

(2) Before granting an exemption, the chief executive may require the person to supply any evidence to show that compliance with the requirements under clause 4 would be unsafe for the vessel.

(3) The chief executive may revoke an exemption granted under subclause (1).

Preamble

The variations set forth in the Schedule below are variations to Standards in the *Australia New Zealand Food Standards Code* published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, which have been varied from time to time.

These variations are published pursuant to section 23A of the *Food Standards Australia New Zealand Act 1991*.

These variations may be collectively known as the *Australia New Zealand Food Standards Code – Amendment No. 96 – 2008*.

Commencement

These variations commence on 21 February 2008, with the exception of Item [1.4] which commences on 21 February 2009.

Specification for agarose ion exchange resin

(a) This specification relates to agarose, cross-linked and alkylated with epichlorohydrin and propylene oxide, then derivatised with tertiary amine groups whereby the amount of epichlorohydrin plus propylene oxide does not exceed 250% by weight of the starting quantity of agarose.

(b) The resins are limited to use in aqueous process streams for the removal of proteins and polyphenols from beer. The pH range for the resins shall be no less than 2 and no more than 5, and the temperatures of water and food passing through the resin bed shall not exceed 2°C. pH and temperature restrictions do not apply to cleaning processes.

(c) When subjected to the extraction regime listed in the CFR Title 21 part 173.25(c)(4), but using dilute hydrochloric acid at pH 2 in place of 5% acetic acid, the ion exchange resins shall result in no more than 25 ppm of organic extractives.
