Classification of Reserves—Porirua City

Under section 16(2A) of the Reserves Act 1977, and a delegation from the Minister of Conservation, the Porirua City Council, pursuant to a resolution dated 18 October 2017, gives notice that:

- a. The reserves described in the First Schedule are classified as recreation reserve;
- b. The reserve described in the Second Schedule is classified as local purpose (accessway) reserve;
- c. The reserves described in the Third Schedule are classified as local purpose (landscape) reserve;
- d. The reserve described in the Fourth Schedule is classified as local purpose (fitness trail) reserve;
- e. The reserves described in the Fifth Schedule are classified as local purpose (neighbourhood) reserve;
- f. The reserves described in the Sixth Schedule are classified as local purpose (flood protection, ecology and pathways) reserve;
