Open for Written Comment—Redcliffs School and Redcliffs Park

Proposal to Exercise the Power Under Section 71 of the Greater Christchurch Regeneration Act 2016 to Designate Redcliffs Park for Education Purposes and for the Existing Redcliffs School Site to be Rezoned as Open Space ("Proposal")

 - Part Lot 3 DP 1228 CB190/67;
 - Lot 1 DP 7624 CB372/72;
 - Part Lot 2 DP 1228 CB495/17;
 - Part Lot 3 DP 1228 (New Zealand Gazette, 30 October 1924, No. 70, page 2596); and
- change the zone of the following parcels of land at the existing Redcliffs School site to Open Space Natural Zone:
 - Part Lot 8 DP 11088; and
 - Part Lot 2 DP 1228.
