

Classification of Reserves

Under section 16(2A) of the Reserves Act 1977, the Thames-Coromandel District Council, pursuant to a resolution passed at its Ordinary Meeting of 2 April 2019, hereby classifies the reserve land described in the First Schedule hereto as recreation reserve, in the Second Schedule hereto as local purpose (esplanade) reserve, in the Third Schedule hereto as local purpose (accessway) reserve, in the Fourth Schedule hereto as local purpose (segregation) reserve and in the Fifth Schedule hereto as scenic reserve, subject to the Reserves Act 1977.
