Early Childhood Services (Recognised Qualifications for Persons Responsible in a Playcentre) Notice

- 1.  - e. New Zealand Diploma in Early Childhood Education and Care (Level 5) NZ2851, 120 credits; or
 - f. Playcentre in Context (course 5 of the Playcentre Diploma in Early Childhood and Adult Education); or
 - g. Diploma in Early Childhood Education (Level 5) WR3009 Waiariki Institute of Technology, 120 credits; or
 - h. Diploma in Early Childhood Education (Level 5) 110016 Manukau Institute of Technology, 121 credits; or
 - i. Diploma in Early Childhood Education (Level 5) PR4911 Whitirea Institute of Technology, 260 credits; or
 - j. Certificate in Early Childhood Education (Level 5) CA2282a Unitec, CN0904 University of Canterbury, PC9774 NZ Tertiary College or Auckland University of Technology, 120 credits; or
 - k. Certificate in Education (Level 5) AK1275 Auckland University of Technology, 120 credits; or
 - l. New Zealand Certificate in Nanny Education (Level 5) 109540 Nanny Organisation of NZ or PC9101 Ashton Warner Nanny Academy, 120 credits; or
 - m. Certificate in Childcare, Education and Home Management (Level 5) 109272 The Nanny Centre (NZ),153 credits; or
 - n. National Certificate in Early Childhood Education and Care (Level 5) 430, 126 credits; or
 - o. Diploma of Teaching (Early Childhood Education) (Level 5) PC1993 Bethlehem Tertiary Institute, 120 credits; or
 - p. Diploma of Teaching (Early Childhood Education) (Level 5) WGES02 Victoria University of Wellington, 180 credits; or
 - q. Certificate in Early Childhood Teaching (Level 6) PC2773 NZ Tertiary College, 240 credits; or
 - r. The Playcentre Diploma in Early Childhood and Adult Education (Level 6) PC9565, 190 credits; or
 - s. The New Zealand Diploma in Early Childhood Education and Care (Level 6) NZ2852, 120 credits; or
 - t. Playcentre Sessions (course 3 of the Playcentre Diploma in Early Childhood and Adult Education); or
 - u. An Early Childhood Education teaching qualification recognised by the Education Council of Aotearoa New Zealand for registration purposes.
- 3. Until 31 December 2020, the following qualifications are also recognised and deemed to be equivalent to the Playcentre qualifications listed in clause 2.
 - a. National Playcentre Certificate; or
 - b. Playcentre Federation Association Certificate; or
 - c. New Zealand Playcentre Federation Inc. Certificate.
- 4. This notice revokes the notice titled "Early Childhood Services (Recognised Qualifications for Persons Responsible in a Playcentre) Notice", published in the <u>New Zealand Gazette</u>, 28 Jan 2019, <u>Notice</u> No. 2019-qo352.
- 5. This notice comes into effect on **24 February 2020**.
