

New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2023/002

Pursuant to section 61(3) of the Government Rounding Powers Act 1989, and section 22AB of the Land Transport Act 1998, the NZ Transport Agency hereby makes the following bylaw.

1. Title and Commencement

This bylaw is the New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2023/002 and will come into force on 19 January 2024.

2. Amendments
