Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Notice 2023

Pursuant to section 113C of the Fisheries Act 1996, the Secretary of Foreign Affairs and Trade gives the following notice.

Notice

1. Title

This notice is the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Notice 2023.

2. Commencement
