In accordance with sections 80L and 80M of the RMA, the Minister for the Environment directs Tauranga City Council to notify decisions on the independent hearings panel's recommendations for Variation 1 to Plan Change 33: Tauriko West Urban Growth Area in accordance with clause 102 of Schedule 1 of the RMA by 31 December 2025.

Minister for the Environment's Additional Direction for the Intensification Streamlined Planning Process to Tauranga City Council

In accordance with clause 80L(1)(d) of the RMA, the Minister for the Environment directs Tauranga City Council to provide a report to the Ministry for the Environment every three months from the date of this notice about its progress of the intensification streamlined planning process for Variation 1 to Plan Change 33: Tauriko West Urban Growth Area.

3. Principal Notice
