Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Notice 2024

Pursuant to section 113C of the Fisheries Act 1996, the Secretary of Foreign Affairs and Trade gives the following notice.

Notice

1. Title

This notice is the Fisheries (High Seas Fishing Notifications—Commission for the Conservation of Antarctic Marine Living Resources) Notice 2024.

2. Commencement

This notice comes into force on the day after the date of its notification in the New Zealand Gazette.
