

## **New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2023/006**

Pursuant to section 61(3) of the Government Rounding Powers Act 1989, and section 22AB of the Land Transport Act 1998, the New Zealand Transport Agency hereby makes the following bylaw.

### **1. Title and Commencement**

This bylaw is the New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2023/006 and will come into force on 6 May 2024.

### **2. Amendments**
