

## The Psychotherapists Board of Aotearoa New Zealand (Fees) Amendment Notice 2024

Pursuant to sections 130 to 133 of the Health Practitioners Competence Assurance Act 2003, Te Poari o ngā Kaihaumanu Hinengaro o Aotearoa, the Psychotherapists Board of Aotearoa New Zealand gives notice that the following fees are effective as of **27 January 2025**.

### Notice

#### 1. Title and commencement

- (1) This notice may be cited as The Psychotherapists Board of Aotearoa New Zealand (Fees) Notice 2024.
- (2) This notice comes into force on **27 January 2025**.

#### 2. Fees

- (1) The Psychotherapists Board of Aotearoa New Zealand ("Board") sets the following fees, payable to the Board, specified in the Schedule below.
- (2) This notice revokes and replaces all previous Board Fees notices.

#### 3. Tax

The fees listed below are inclusive of goods and services tax (GST) of 15%.

#### 4. No refund

- (1) All fees charged by the Board (in \$NZD).
- (2) Fees are not refundable when an application is declined.

#### 5. Waiver

The Board may provide for the waiver or transfer of any fee, or part thereof, in accordance with current policy at the time the fee is paid.
