

New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2024/004

Pursuant to section 61(3) of the Government Roading Powers Act 1989, and section 22AB of the Land Transport Act 1998, the NZ Transport Agency hereby makes the following bylaw.

Bylaw

1. Title and Commencement

This bylaw is the New Zealand Transport Agency (Traffic Controls on State Highways) Amendment Bylaw 2024/004 and will come into force on 10 March 2025.

2. Amendments
